Commissioners Schroeder, Schlumbohm and Lammers, and Tim Schnipke went to view the landfill and the ponds. Some rip rap will be needed to help with the erosion and drainage issues.

Commissioner Schroeder called the meeting to order with Commissioners Schlumbohm and Lammers by reciting the Pledge of Allegiance.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers, Cindy Landwehr, Clerk and Martin Verni, Putnam County Sentinel.

The minutes from Tuesday June 16, 2020 were reviewed and approved.

A Joint County teleconference was held with Allen, Hancock and Putnam Commissioners to discuss the collection of maintenance on the Moyer Tri-County Ditch.

Kevin Niese or Technicon Design Group and John Schimmoeller and Craig Schroeder of Schimmoeller Construction met with Commissioners Schroeder, Schlumbohm and Lammers and Tim Schnipke to discuss the status of the courthouse renovation project. The condition of the Annex building will also be addressed. Kevin covered a punch list of items that needed to be addressed. The bolts on the railing got tightened and epoxyed, debris clean up, The landscaping stone will be added by the county. Trisco will come back and clean and seal when there is ground cover. There will be some settling yet in the old ramp area and new area. It will get sprinkled to get it to settle better. The area between the steps and new ramp needs cleaned and sealed yet. Fabric will be used for the seeding. Felt could be used also. A piece of angle iron trim is missing from a corner on the door. The caulking does not match but it wasn't in the specs to match. The color wanted does not come in the big tubes. Commissioner Schlumbohm suggested a different brand that does come in the color needed. Sand would need to be added as soon as the caulk is done. The Commissioners may be willing to split the cost to re-caulk due to lack of clarity in the specs, which would be about \$1,000 to the County. The area between the retaining wall and sidewalk should be caulked also. On both side of new ramp and steps would need to be re-caulked. The colors used don't match. The same color and same products need to be used. It will get dirty but if the sand is added at first then there would be nothing left for dirt to stick to. The paving was discussed to redo the area that was cold patched instead of asphalt since it was too late in the season for asphalt. Schimmoeller requested a change order to redo the paving. The County did not change the schedule, Schimmoeller did. It was not the County's fault the project was behind and extended. The whole project should have moved faster. The cost to remove the cold patch and put in asphalt is not known yet. Is the street going to get ground out further? It would get paved and be graded and tapered better with the sidewalk to not pool water. Water does pool in that area. Ward can advised about a fix for leveling. Kevin asked what percentage of asphalt work is left to do yet according to the pay application? Schimmoeller said he should have use stone instead of cold patch to facilitate removal for the final repaving. Roofs are done. Drain caps that match are on. The base warranty on the roof is 20 years and it will be reexamined periodically after that.

The Annex building was reviewed with Kevin and the Commissioners. The brick exterior has bricks popping out and tucking and pinning would not be able to match the current brick. Some other options were discussed for repairing brick finish or dry brick and some buildings that have them so the Commissioner can view them. Kevin is still getting prices in for rehabbing the building between masonry, plastering and painting. He will compare the prices to a new construction as well. If it is rehabbed it is still an old building within the flood plain. It would have to be raised at least 18 inches if rebuilt on same site. The Commissioners will review all the options before a decision is made.
