Karl said he worked at the recycling drop off this morning and had a few people dropping off items that are not acceptable. The commissioners asked Karl to come back for the 1:30 meeting with the Villages on recycling. We would like to see signs above each bin showing pictures of items that are accepted also.

Commissioners returned from lunch.

Commissioners Schroeder, Schlumbohm and Lammers met with the Villages that have mobile recycling sites Leipsic-Justin Barnhart, Continental- Susan Darby, Columbus Grove- Jeff Vance and Kalida- Jon Edelbrock. The commissioners wanted to make everyone aware of the amounts of contamination coming from the recycling bins that their village has a week at a time in a month. Pictures were passed around showing some of the contamination like vinyl siding, tarps, black plastics, garbage bags, etc. We talked about the different ways we are trying to improve recycling. Alaina Siefker told them how the drivers report some items and the camera video is watched. When someone is found putting something in that is not supposed to, the vehicle plate along with the screen shots are sent to Ottawa PD and the Sheriff's Office. If they are in town, the PD takes care of doing the verbal warning and if it is outside village limits, the Sheriff's Office does the verbal. They are also told they will be getting a warning letter from the Prosecutors Office and his office prepares and send them out. One of the letters were given to them along with the recycling brochures. It was discussed to link the recycling webpage to their websites and possibly sharing info on social media. Susan asked about our camera system. Leipsic wanted the info as well. Education and signage was decided to be the top items. We also let them know we will be eventually separating 1s and 2s in plastics. Thought about putting dividers in bins for that. Possibly putting divider in another bin for metal and paper to be split. Everyone was very receptive on working together to try to help this program.

Bob Benroth stopped in to give the Commissioners an update on the monthly sales tax numbers. Bob reviewed the numbers with the Commissioners the direct pay numbers have decreased. With the weather we have had will also have an effect on the future sales tax figures the purchase will decrease due to the farmers not getting the income due to the late planting or no planting. The budget has been reviewed and as of now expenses do not equal the revenue. There are still a few departments that have not submitted their numbers. The sheriff submitted an increase of \$558,872. Which was not explained in their budget meeting. The raise increase should have been 3% across the board some department put it in but most did not. Bob asked about any future capital improvement projects also. Are all the projects for this year encumbered? Yes. Will the Annex be replaced or repaired in the coming years? The Commissioners will have to discuss what to do with the county offices. The possible income from the solar farm was also discussed.
