The Commissioners received a letter from Dean Williamson, of Continental Fire Department regarding an incident with the EMS, the procedural issues and the behavior of the EMS employees. The Commissioners will address this with the EMS director.

Tim Schnipke stopped in to give the Commissioners an update on the rodent problem at the Ag Complex and a fair update. Tim presented figures for new lighting at the fairgrounds which includes a rebate that is ending in July.

Amy Hoffman of Palmer Energy met with Commissioners Schroeder, Schlumbohm and Lammers to discuss solar contracts. Amy gave a recap of the current situation with Government aggregation is up next year for Pandora, Riley and Dupont. They are trying to get the county on the same cycle but will take a few years. Facilities are separate. Ottawa is now participating as well but under a different program. The villages within the County were reviewed for participation also. Which Villages that are on AEP versus Paulding Putnam was discussed. There have been changes made to solar agreements. They are now hedged as a fixed rate, which will be extremely competitive. The supplier contract will still be done at market rate as well as a fixed rate to make it a blended rate. The project will be in southern Ohio, up and running by spring 2022. The developer cannot determine the prices until the letters of intent are received. There is a tariff on solar panels that are imported. The developers are not known yet. They need to sell the power before the project can start. Rates could be higher the first few years, but nothing is set until the pricing comes back. The projected market figures were discussed. Putnam has the lowest rate currently due to the markets. It is thought that all the developers are all American. The Commissioners would like to confirm the companies will be American. Amy presented a sample letter for Intent for Potential Purchase of Solar Generated Energy. The Commissioner have a meeting with a developer this week on a Local solar project. The letter of intent are due August 1. The Commissioners are interested. Palmer is interested in getting in the solar market. The electric rates will not stay this low. Solar use will increase due to the costs.

The business agenda was held with the Commissioners Schroeder, Schlumbohm and Lammers, and Cindy Landwehr, Clerk.
