Gary Lammers met with Commissioners Schroeder, Schlumbohm and Lammers to discuss compensation and land transfer. The Commissioners brought up employee compensation as a whole over all departments. The Commissioners are looking at making the wages for County employees more comparable for longevity and experience. A plan for getting wages in a proper range is being made to eliminate or lower the current gap in the wage rates among the current

employees. The plans for the Annex building and moving office locations was discussed. The land transfer was brought up and any land transactions could be done through the CIC. A land swap was presented for a trade in land parcels that the County is interested in. Gary asked about the development plans for the land in question. Gary said the Commissioners may want to consider future prospective uses for the land to determine the proper value. Gary also encouraged the Commissioners to keep the judges in the loop for the building and office plans.

Gary gave an update on the Unterbrink case, a phone pretrial will be held on June 30. Gary also updated on the Veteran Service case it is still under investigation.

Joe Burkhart stopped in and the Commissioners asked about moving his office to the fourth floor with the server. Joe said that would not be a problem. The Commissioners also asked about updating the servers and the plan and timing for it. Joe said he has an eight-year plan for updating. The Commissioners want to know what will need to be updated so they could add it to the American Rescue Plan funds if needed.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday June 1, 2021 were reviewed and approved.

Commissioner Schlumbohm left for the day.

Commissioners Schroeder and Alaina Siefker held an interview with Cole Fenstermaker for a position at the Recycling Center.
