Tim Schnipke stopped in to give the Commissioners an update on the Sewer Dist #2 pump station. He said it needs to be moved up on priority list to be replaced due to increased repairs needed. Mr. Schlumbohm is working on the plans for replacing it, he is working with Advanced Rehab on the plans. Tim said the pump is getting checked daily and is increasing on maintenance needs. The repairs that have been done have helped but there are other electrical issues in the control panel. The panels will be going to three phase electric and then the pumps will need to be replaced to be compatible with the three phase. The roof at the Ag Complex that had the rotten area will be repaired while the roof is being replaced. Tim showed progress pictures of the roof. The asphalt was laid yesterday at the Glandorf Complex parking lot. Mr. Schlumbohm joined the meeting. Tim explained a change order that will be coming for the parking lot and he asked if parking blocks would be needed. The Commissioners were in agreement to purchase the parking blocks. Tim gave an update on the Landfill maintenance and the spraying that is needed. Tim asked when Morman's will be mowing as it will determine the next spraying. Prime spraying will be in September. Wellman was here last week to view the courthouse roof and advised that additional roof drains will be needed on the Courthouse. These drains were not included on the prints that were done by Technicon Design Group. The additional drains will be additional costs to the gutter system. No quotes have been given for these changes yet but it will be costly. The contractor will do as-built drawings and new drawings from Technicon should not be needed. The materials for the drains were discussed. The remaining records in the attic needs to be removed so these drains can be worked on. The additional gutters will be needed to hopefully reduce any future maintenance needs.

Commissioners Schroeder, Schlumbohm and Lammers attended the Elected Officials meeting in the lunch room.

The business agenda was held at 10:00 a.m. with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The second public hearing for the Leipsic CDBG NRG project was held at 10:30 a.m.

The minutes from Thursday May 30, 2019 were reviewed and approved.

Commissioners contacted Bockrath & Associates for engineering and drawing up the new pump for sewer district #2. A grant application will be included with the engineering for the pump. Certified estimates from an engineer will be needed for the grant application. Greg Bockrath will put together a quote to present to the Commissioners.
