## COMMUNITY DEVELOPMENT BLOCK GRANT CITIZEN PARTICIPATION PLAN:

In an attempt to provide local citizens with the opportunity to participate in the planning, implementation and assessment of the Community Development Block Grant (CDBG) Program. Putnam County will hold public hearings. Newspaper announcements, public notices and website announcements of the scheduled public hearings will appear at least ten (10) days prior to the hearing dates and will list the date, time, and location of each hearing. Hearing locations will be convenient and accessible to potential beneficiaries and will allow for handicapped accessibility. In the event a significant number of non-English speaking residents are reasonably expected to attend a public hearing, arrangements will be made to provide an interpreter/translator, and bi-lingual advertisements/notices will be provided, as necessary.

The first public hearing will be scheduled at the initial stage of application preparation. The purpose of the hearing will be to discuss and explain all CDBG programs. The proposal application deadline for the Formula/Allocation Program will be announced at this hearing, as well as the date for the second public hearing.

The second public hearing will be held prior to final preparation of the funding application. The purpose of the second hearing is to solicit public comments and publicly announce the projects proposed for funding.

In addition to the newspaper advertisements, letters will be sent to local governments, public service agencies and other interested parties including groups which serve primarily persons from LMI households within the jurisdiction, advising officials of funding availability and the first public hearing date. Minutes of the public hearing will be on file in the office of the Board of County Commissioners within the Citizen Participation file. Records and information concerning the CDBG Formula Program are available for public viewing and copying during normal business hours at the office of the County Commissioners.

Citizens are invited to provide input and comments throughout the funding program. Any written complaints/grievances will be answered within fifteen (15) working days where practical.

Any groups representative of low-and-moderate-income persons who require assistance in application development may contact the county commissioners' office for technical assistance. The needs of all local governments and all residents will be considered in preparing the funding application.

The Putnam County Commissioners shall amend its approved plan whenever it makes one of the following decisions (See §§ 91.105and 91.115.):

- (1) To make a change in its allocation priorities or a change in the method of distribution of funds;
- (2) To carry out an activity, using funds from any program covered by the <u>consolidated plan</u> (including program income, reimbursements, repayment, recaptures, or reallocations from HUD), not previously described in the action plan; or
- (3) To change the purpose, scope, location, or beneficiaries of an activity.

This resolution will take effect upon signing.

WHEREAS, this Memorandum of Understanding ("MOU") sets forth the terms and understanding between the following entities: Blue Harvest Solar Park, LLC a Delaware limited liability company (herein referred to as "Solar Company"); Putnam County, OH Commissioners (herein referred to as "Putnam County"); and the Monroe Township, Putnam County, Ohio Trustees (herein Solar Company, Monroe Township and Putnam County are jointly referred to as "the Parties"). The terms and understanding between the parties pertain to the installation of a solar-powered, electric generation farm on parcels of land located near Continental. Ohio and:

WHEREAS, Solar Company is seeking to install a solar-powered electric generation facility within Putnam County, Ohio on parcels of land located within the boundary of Monroe Township ("Solar Project" or "Project"). The Project will include the installation of solar modules and associated facilities, within the subject parcels. The energy derived from the solar power will be used to contribute to the regional electric grid, enhance the economic vitality of the surrounding community(s), and enhance solar technologies for the region. The Project will generate naturally derived energy with an anticipated lifespan of 35 years and;

WHEREAS, the parties desire to develop an MOU that offers public stakeholder involvement and review of the Solar Project, as well as, considers the needs and direction of the Solar Company. The Purpose of this MOU is to form an agreement between the parties regarding design standards, Project approval requirements, pre-construction requirements for the Solar Project, and to outline the responsibilities of each party, therefore;

BE IF RESOLVED, that the Board of Putnam County Commissioners does hereby enter into a Memorandum of Understanding with Blue Harvest Solar Park, LLC and Monroe Township; a copy of this Memorandum of Understanding is on file at the Putnam County Commissioners Office 245 E. Main Street, Suite 101, Ottawa, OH 45875.

Lori explained that Harris the current vendor is providing this service as an add on feature. Lori reviewed the charges with the Commissioners. Lori said she can cover the annual maintenance fees. Lori is waiting to view the quality of the images prior to signing off. The Commissioners agree to this scanning project to save on needing to hire an additional person. Lori did hire a part time person. Lori is working to get the new scanner that was purchased, up and running to get the mortgages scanned.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday June 3, 2021 were reviewed and approved.

Tim Schnipke stopped in to give updates on maintenance projects. They will be working on the fairgrounds in the evenings to get things done in time.

Commissioners resumed session.

Ali Stano, of EDP Renewables and Steve Elkins & Rob Howell, Monroe Township met with Commissioners Schroeder, Schlumbohm and Lammers along with Amy Kurt, Chris Pirik and Chad Gardner also of EDP Renewables joining the meeting via Zoom, to discuss the Blue Harvest Solar project and review the PILOT payments. Ali gave a project update. They have completed the permitting phase with a twin project in Paulding County. The MOU have been approved. The construction will start spring of 2022 with operations starting in fall of 2022. There are two landowners and can be expanded to 15 landowners, which will get a "good neighbor stipend" that are adjacent to the project. The Commissioners brought up the resolution and the revision for the AEZ and PILOT payments. Ali has met with the Prosecutor. The road use agreement is in process Roads 22 & G will be the only roads used. The RUA will cover the repairs needed to the roads that are used. The type of panels being used were questioned. 540 watt panels will now be used. The output cannot go over the 49.9 limit. The panels will not be made in America but there are components that are manufactured in America. The technology being used was questioned. The panels will be bifacial so both sides can be used. The height and size of panels was discussed for land use purposes if livestock could be on the land also. Commissioner Schroeder asked what drew them here to our area. They have received great support in this area. The breakdown of the payments was discussed a portion will go to the fire department also. The Commissioners reviewed the MOU resolution and clarified that the AEZ and PILOT will be adhered to. Amy added that they are talking to people with OSU about double harvesting on the land and crops that could be grown such as alfalfa. Commissioners suggested beekeepers also. The larger projects take longer due to the regulations and permitting through the Power Siting Board. The Miller City project was brought up. Adding referendums to a project adds a lot of time. Ali explained the research that goes into a project. The need for local control of these projects was emphasized. The dairy farms were also discussed as well as the plans for expansion and the manure handling. Commissioner Lammers brought up the TID creation too, that would benefit the townships. The trustees brought up the conditions of their roads due to the use by the dairies.

Commissioner Schlumbohm left for the day.

Commissioner Lammers attended the Records Commission meeting with Lori Rayle, Sherri Britsch, Kim Redman and Jeremy Maag. There were no items to review. The next meeting will be September 7.
