Minutes, Monday March 16, 2020

Commissioners Schroeder, Schlumbohm and Lammers met with all departments at 1:00 p.m. to give and receive updates on the latest procedures in dealing with COVID 19. It was recommended by the Health Department for all offices to encourage phone and email use as much as possible to conduct business with the public to decrease unnecessary trips and exposure for all. Other options were to leave office doors open so they don't need to be touched. The cleaning of high traffic areas will be done regularly.

Joe Hohlbein and Adam Schimmoeller met with Commissioners Schroeder, Schlumbohm and Lammers to discuss closing procedures for the recycling program. Signs will be posted and the gates will be closed.

Mike Klear met with Commissioners Schroeder, Schlumbohm and Lammers to request additional funds of \$20,000.00 for purchasing emergency supplies for dealing with the virus. He also suggested the Commissioners look into calling an Emergency for the County. The Commissioners will consult with the Prosecutor for the procedure for declaring the emergency. If an Emergency is declared then the Directors time can be paid as comp time rather than a flex time. Glandorf Telephone is setting up the hotline for call center. Once the essential personnel

and duties are identified then the plans can be made further. If EMS is quarantined or isolated and they refuse to stay home, a plan needs to be made. Alternative accommodations would be needed to contain any contaminants to not spread to their families and other employees.

Tuesday March 17, 2020

Mr. Schroeder called the meeting to order with Mr. Lammers by reciting the Pledge of Allegiance.

Commissioners Schroeder and Lammers and Alaina Siefker attended a virtual meeting with Jamie Zawila of Resource Recycling Systems Inc. We reviewed an estimate from Jamie for being a consultant for the Solid Waste Plan Update that the final is due September 1, 2022. She went over the differences between the 3.0 and 4.0 version. Commissioner Lammers said the person who did the plan the last time is no longer with our office so this is all new for Alaina. I am very confident that once you give her some guidance, she will be very capable of doing this. He asked Jamie if we would have to do this again in another five years and she said yes, but she can give Alaina all the tracking information spreadsheets and she should be able to do it then. Jamie worked with another county that did that. They helped with the first one for them and then they haven't been back since the lady had what she needed to track in spreadsheets. Commissioners Schroeder and Lammers both said they wanted to do the 4.0 version and think that we would all work together very well for this. They requested a PO be put on the agenda for Thursday and then we will let her know if they approved it.

The business agenda was held with Commissioners Schroeder and Lammers, Cindy Landwehr, Clerk.

Commissioners Schroeder, Schlumbohm and Lammers held discussions regarding identifying department priorities with the office staff and maintenance staff. The priority duties of office staff were identified as agendas, public notices, paying bills and payroll. The priorities of the maintenance staff are of course additional cleaning and sanitizing high traffic areas. Three levels of operations were identified as

Level 1 -limited access

Level 2-No public access only employees

Level 3- Closed no employees no operations-similar to a snow level 3

The cleaning will have more emphasis on sanitizing and disinfecting rather than sweeping. The courtroom benches are getting sprayed with Lysol. New part time cleaning positions were considered to help with the cleaning workload. And other staffing issues with maintenance were discussed. The authority is not know as to who has final authority to close the courthouse and to determine the levels to operate at. The Sheriff's office cleaning needs were discussed. Deb does not clean the Sheriff office, she cleans the courthouse, annex, Ag Complex and BOE and Home Health at O-G Road Complex. If everything would be shut down and closed the buildings would still need to be checked daily. If a Level 2 status would happen then the Commissioners intend to meet once per week to pay bills and conduct business. Everything is under the direction of Ohio Department of Health. The leachate pumping was asked about if it would be needed. Things may be looked at for employees to work from home. The CDBG grant is not

stopping yet, so the contractors are not stopping either. The sewer billing was just completed for the month. The courthouse project is still on hold until April unless further notice comes from the State. It was stated that if you don't feel good stay home. The Commissioners are asking for continued operations plan- prioritized duties from all offices to consider declaring a state of emergency for the County.

The minutes from Thursday March 12, 2020 were reviewed and approved.
