That pursuant to said Notice, this Board be and hereby is authorized to conduct two (2) Public Hearings on the proposed levy to renew the rate of sales tax. Said hearings shall be held in the General Assembly room in the Putnam County Courthouse in the Village of Ottawa, Ohio, on March 30, 2021 at 11:00 a.m. and April 7, 2021, at 7:00 p.m.

Commissioners Schroeder, Schlumbohm and Lammers reviewed the list of inmates working at Recycling and want to talk to Joe about their job performance.

Tim Schnipke stopped in to give the Commissioners an update on the leak repair at the Ag Complex. He said the leak was located and the pipe is plastic. The pipe will be repaired. Tim said the new floor drain in the shop is in progress. The concrete is cut out and the drainage is put in there is a trench drain and will be connected to the downspouts from the roof and an outlet tile. The drainage is in and the drain will be set, cement will be poured next week. Tim is getting prices for parking lot restoration at the Health Dept. He has requested bids from Morelock and Ward Construction. Paving, grinding and re-striping will be included in the restoration. Tim wants to square up the lot with the Village and make it easier for plowing snow. The asphalt plant may open in April depending on weather. Klausing painting gave quote on the painting at the Health Dept and at the Ag Complex. They will work on landscaping and caulking the Jail roof. Tim is thinking about hiring additional summer help depending on what the Commissioners want to do. Tim figured his staff could do the caulking. Tim also brought up fixing the drain in the Recycling Area. There is lighting to finish at the Fairgrounds also. He also had prices for spray and fertilizer for all the County properties. The maintenance guys are all licensed to spray. Vince asked about getting nitrogen for the grass at the Landfill. Tim said it couldn't hurt. The secondary drive at the Landfill needs some stone also. Tim will get prices for fertilizer at Landfill. Tim presented quotes for the HVAC units at the Annex from Wagner Plumbing & Heating and Schroeder Plumbing & Heating. Tim wants to make sure the guotes are for identical equipment. Trisco will start on the steps at the Annex next week.

Joe Hohlbein came in to talk to Commissioners Schroeder, Schlumbohm and Lammers about the Recycling employees and their performance. The Commissioners reviewed the discipline process with Joe and what steps need to be taken when dealing with employees. There are a couple employees that need some disciplinary measures taken toward them. The Commissioners explained the idea of issuing cards for entry into the Recycling area to log who is utilizing the recycling service. The possibility of having some villages contract out to collect recycling to compensate for not opening the other village collection sites. The market on outgoing product was discussed, the prices are going up slightly. The Commissioners asked about getting the hook for the tubs. Joe got a quote for hooks from Kalida Truck. Vince said there is a fabricator that will make them but need to see one for specs. A portable welder may be needed to install the hooks on the tubs. Joe recommended waiting until we get the new truck before we start making modifications to the bins to confirm the measurements so the bins will fit on the truck properly and securely. The Peterbuilt is being used more than the International. The arrival date of the new truck is not known yet.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday March 2, 2021 were reviewed and approved.

Ashley Siefker, grants and wages coordinator talked to the Commissioners about the set up of the next CHIP application. There was a phone call between her, GLCAP, Delphos and Allen County representatives to discuss preliminary application actions needed. Because there was an extension on the 2017 grant there is a 'penalty' for the upcoming application. If Allen County would talk the lead on the 2021 grant then that 'penalty' would not exist because it would be a new application and a lesser chance of not being funded. The other option is to keep things as they are knowing there is a higher chance of not being funded. If that would happen then we could apply again in a year and the penalty would have been served and no longer a factor. The Commissioners are ok with Allen County taking lead if they are willing contingent that Putnam would retake the lead for the 2023 CHIP application. If they are not willing to take point then they would like to apply as we are now and serve the penalty and try again in a year if not awarded. Marlene is discussing the options with the Allen County Commissioners as well. There is a follow-up meeting at the end of next week between the above parties to discuss what was decided and make a plan accordingly. Ashley will inform the Commissioners of what come of it.
