Commissioner Schroeder called the meeting to order with Commissioner Lammers by reciting the Pledge of Allegiance.

Commissioners Schroeder and Lammers held a teleconference with Mike Lenhart regarding the truck traffic on Road 6. Mr. Lenhart said there are plans to improve Road 6 in the near future.

Paulette Mills and Matt Miller held a teleconference with Commissioners Schroeder and Lammers and Ashley Siefker regarding the request to resubmit Continental's Critical Infrastructure Application. The Commissioners had previously supported an application for the project which was not awarded. They would like to resubmit the application again for the next

round of funding and are asking for the Commissioners' support on the new application submission which is June 15. There was some feedback on the previous application which will be added to the application. The project is new storm sewer and road reconstruction including asphalt. Continental is working to upgrade the water lines within the village as well. The Commissioners' said Continental is looking up and the progress is showing.

The business agenda was held with Commissioners Schroeder and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday May 5, 2022 were reviewed and approved.

Tim Schnipke stopped in to give maintenance updates on the roof replacement at OSU Extension. The courthouse air units are progressing. The piping to the air handler needs to be replaced and will be flushed. The piping was not originally included in the project but it is rusting and should be replaced. The piping the basement was inspected also and will need replacement. Tim said he will be buying a pro-press to maintain the pipes in the future. He has tried the Pro-press from the contractor doing the replacements. Tim explained the piping for each floor's units and how they are all different and the changes needed for each floor for the units. The unit replacements should be completed in 2 weeks. The timing of the air unit replacement at the jail was discussed. The power panel in recycling is moved. Vince asked about the concrete work needed at the entrance to recycling. Tim said his department cannot handle pouring it, it would be too much. Tim can take care of tearing down the small structure in the back. The driveway approach to recycling was discussed. Tim wants to confirm that this is the final plan and not have it change again in a year or two. He is requesting that some thought and planning go into it before final decisions are made. The history of where recycling has been located within the building was discussed. Originally the site in the building was chosen because the roof did not leak. Now that the majority of the buildings of the Ag Complex have had the roofs replaced so there are more options.
