Commissioners Lammers, Schlumbohm and Schroeder met with EMA Brian Hilvers, the Sheriff and Health Dept. Kim Rieman to discuss a PIO (Public Information Officer) position for the county. Hilvers said they would like to look into a part-time position for the county for getting the correct information out by one person. Mr. Lammers questioned when a part-time government job ever stayed part-time without eventually becoming full time? The job of informing the public/press is part of the leadership role of the elected officials and department heads and they should be responsible for that. The time it takes to correctly inform a PIO could just as easily be used to inform the public/press. The commissioners don't like that government would be putting out information for everyone. They think they should designate someone in the office to do that and there should be someone in each office that can do that. Kim Rieman said the job for all of the agencies is to educate and get the correct information out and a PIO would be the person to gather that information. A press conference could be scheduled and give the information out correctly. When you don't have that, you have a mess of incorrect information. The commissioners asked why you would do that with someone that isn't tied directly to each agency. Kim has an employee that part of her job is being the PIO for the Health Dept. The commissioners would like each office to have someone and to learn it. Kim said last week she had Ashley Siefker in the Commrs. Office reach out to her about a survey GLCAP needed her to send out and mentioned that Ashley reached out to other county agencies to ask them to post it since the county doesn't have their own page. The commissioners asked how the position would be funded, maybe all three budgets would pay for it but the commissioners would like to see it by each office having someone to do it and would like to have more information on this like what other similar counties our size do.

Commissioners Schroeder, Schlumbohm and Lammers and Maintenance Tim Schnipke called Kevin Niese from Technicon to discuss holes drilled into the new building because of moisture from rain. It was discussed on the best way to proceed with fixing the issue to be communicated to Helms. This has been an ongoing issue that needs to be corrected before it's too late to fix. Commissioner Schlumbohm suggested getting a third party to test the building for moisture. Kevin will look at the contract to see what it states about patching the holes in the tin versus replacing it. It may be needed to take the roof panels off to replace insulation. This will likely need to happen after the fair for timing purposes. Commissioner Lammers will talk to Joe Kreinbrink about being able to do the moisture inspection.

The business agenda was held with Commissioners Schlumbohm, Schroeder and Lammers and Alaina Siefker. Asst. Clerk.

Commissioners Schlumbohm, Lammers and Schroeder met with Juan Pardo about a Belmore parcel purchase. The Village of Belmore may have to vacate the alley in question. It was suggested to talk to the Village council to see what the specifics are of the parcel ownership and how it's recorded. The GIS map was reviewed and the other side of the alley in question is owned by the Commissioners. Once those things in order then sale can be discussed and put out for bid.
