Mr. Schroeder called the meeting to order with Mr. Lammers by reciting the Pledge of Allegiance.

Mr. Schroeder attended a meeting at the Village of Ottawa with Jack Williams and Doug Schroeder to discuss residential sewer tap in requests and compliant tap-ins.

Mr. Lammers attended the Elected Officials meeting.

Mr. Schlumbohm arrived at the office at 9:30 a.m. and joined the elected Officials meeting.

Mr. Schroeder returned from the Village office and attended the Elected Officials also.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers; Cindy Landwehr, Clerk.

The Commissioners discussed the request for a tap in in Sewer Dist #1. Mr. Schroeder talked to Dustin at Advanced Rehab about the warranty on a coated manhole in Sewer Dist #1 if a tap in is done in the manhole. Other options for tap ins were discussed between Mr. Schroeder and Mr. Schlumbohm. It was discussed to seal or raise the low manholes in Sewer Dist #2 to prevent ground water drainage into the sewer system.

Amy Sealts, and Rachelle Conine from the CIC met with Commissioners Schroeder, Schlumbohm and Lammers to review the CIC annual report. Tom Liebrecht joined the meeting also. Amy shared the annual report and reviewed the jobs that were created and retained. The development projects were reviewed also along with the employment and payroll from those development projects. The CRA, TIF and Enterprise Zone agreement totals were reviewed. Amy also covered business connections within the county for suppliers and providers. The employment needs within the county were also discussed. Amy also works with Suzy at Job & Family on workforce development to develop and inform employers of services available. Putnam does not have the same level of resources as other counties like Allen since the funding is based on population. Amy says the county needs a concentrated approach to resolve the employment issues within the County. The school systems seems to be the main draw to bring

people back to the area. A comprehensive workforce development program is being developed and researched. Events are being created with cooperation of the Education Services Center. Mr. Schroeder discussed the changed in the teaching curriculum that have come about from the State level over the years. More skilled learning is needed. Mr. Schroeder asked about the number of needed skilled jobs within the County rather than the people going to California to get the jobs. The lack of rural broadband is a key issue to lack of job opportunities. There are other types of communication. Why can't there be more defense contractors here in this area? Putnam County is not at a poverty level to receive the funding that is available to other area. Some areas have carved themselves out as the perfect site for the opportunities since the utilities, resources and suppliers (infrastructure) are already set up and running. This area lacks infrastructure and amenities. What is the end result that is desired for the area? Each community within the County has different and diverse needs for development and different desires for levels of development. Spec buildings are big now. Existing buildings are a big desire. We do not have enough workers in the area to fill all the available jobs. Amy would like to develop a plan to have a staffed position for workforce development. She explained Hancock County' setup. Job & Family does not have any people available to help with the staffed position, they need staff to assist the clients they have. The plan to pay the staffed position will need to be developed also. There is no State funding to set up workforce development. There are at least three industries within the county that had to raise their starting pay to retain new employees. The ideas will continue to be developed and then the funding will be looked into. Many businesses within the County would like to expand but will not until they know they will have the employees to fill the jobs. Housing in the area was also discussed and thought of. The local industries may be willing to contribute toward the compensation of the staffed position. This is not an immediate result it will be 5-10 years before anything is recognized in the area. Putnam County does not currently have a workforce development plan but it is being requested more often by new business looking at moving to this area. Some things can be changed locally but something cannot be changed locally. Defiance County has a new workforce development director and program.

The minutes from Thursday May 2, 2019 were reviewed and approved.
