Mostly villages can participate due to the electric cooperatives in the area. The current recommendation is to go to Dec 2023 for the most savings based on the current figures and market. And possibly the solar would be in play also by then. This is the third renewal for the County. The Prosecutor will have to review the new agreement and once approved then a signature will be needed.
