Aaron Vorst stopped in to present a quote for auto door opener for the Annex to Commissioners Schroeder and Schlumbohm. Commissioner Lammers joined via teleconference. Aaron also mentioned a request for auto door openers at the Health Dept. Commissioner Schlumbohm said the Health dept. has funds they need to spend. They can redo the entrance and add some handicap parking.

The Commissioners discussed the request received regarding Road 22 for road improvements due to the large trucks and machinery using this road. It was suggested to have a meeting with the Engineer, Sheriff and Commissioners to discuss this road maintenance matter.

Karen Warnecke met with Commissioners Schroeder and Schlumbohm and Commissioner Lammers via teleconference regarding a vehicle. Karen said it was nice that the Commissioners made the provisions to use the truck. She is asking for a lower vehicle to use since it is too high for the ladies to lift the equipment to the bed of the truck. Karen has some health issues and cannot be lifting. The vehicle is needed for each election and each training session to move the equipment. The Commissioners are trying justify purchasing a vehicle for four times a year. BOE can ask maintenance to assist with the lifting if needed. The trustees have vehicles to accommodate the loading of the equipment. Karen also asked for a vehicle a month prior to the elections for them to keep for the whole month for hauling mail. The Commissioners said there are vehicles available that they can accommodate that request. The different ballots available to the voters were discussed. There are 69 split options for ballots within the County. Karen explained that absentee ballots and early voting are printed as needed to reduce the waste of printing excess ballots. She explained having emergency ballots available also. The Commissioners said if they need the heavy equipment moved to let the maintenance staff know they can help with the moving. Karen also presented updated budget figures for 2023 for the Commissioners to review. The mayors, trustees, clerks and school boards will be up for reelection next year. The Commissioners informed Karen that the tree in question at BOE will be removed. Karen also shared the ADA compliance rules for building so the Commissioners can use them for the new building at the fairgrounds. If needed it could be used as a voting location in the future.

The business agenda was held with Commissioners Schroeder and Schlumbohm and Cindy Landwehr, Clerk.

The minutes from Thursday November 10, 2022 were reviewed and approved.

Commissioners Schroeder and Schlumbohm left to view the conditions of Road 22 near the dairy farm.
