Commissioners Schroeder, Schlumbohm and Lammers held a conference call with a Courier reporter.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday November 17, 2020 were reviewed and approved.

Brandon Barlage stopped in to share drone videos of the river diversion channel with Commissioners Schroeder, Schlumbohm and Lammers.

Commissioner Schroeder, Schlumbohm and Lammers held discussions on the recycling program. Vince said the Commissioners need to view recycling to see if it would be possible to move it indoors for winter and possibly year round. The staffing of the sorting area was discussed. With the staffing of the sorting area has reduced the amount of trash and improved the quality of the product being collected. The satellite locations were discussed as to how/when they can be resumed. There is not sufficient staffing to start them back up at this time. Will the satellite locations be manned as well? Who will provide the staffing would it be the towns? The markets have decreased for pricing. The program is constantly evolving and the spending on it has increased. The weather conditions were discussed as to when to have people outside manning the bins. A viewing is set for next Tuesday at 9:00a.m.

Bob Benroth stopped in to talk to the Commissioners about the purchase of the software for CIC for the job web portal using the CARES money. Bob wanted to clarify the details of the purchase and have the County pay the vendor directly rather than pay the CIC. Bob recommended a resolution turning it over to the CIC after the purchase. A few of the townships and villages have requested their CARES money.

Tim Schnipke and Joe Burkhart met with Commissioners Schroeder, Schlumbohm and Lammers to discuss Home Health renovations in the O-G Road Complex. Tim explained that the meeting room used by Home Health, they want to put in a divider wall. Electrical and fire sprinkler needs to be moved. The records room is also going to be converted to offices. They would like to move their records to the garage rather than to Third Street building. Shelving is needed for the garage. There is another wall that they wanted closed, it has a door in it now. Home Health rents the building from the Commissioners. The lease with Home Health is up at the end of December this year. The Commissioners are interested in renewing the lease for another five years. The maintenance guys will do the work and Home Health will pay for the

materials. Joe explained some restructuring that was done at the last Health Board meeting. The maintenance guys do not do drywall so that will be hired out.

Commissioners Schroeder, Schlumbohm and Lammers held discussions on the Allen County Sugar Creek/Warrington construction assessment collection. Bob Benroth joined the meeting also. Allen County has not been sending the construction assessment along with the maintenance assessment for Putnam to collect for the past few years. Allen County was late in sending the lists for collection this year the tax bills have already been calculated. The Commissioners do not want to bill the parcel owners for the whole amount to collect the past amounts due, the amounts should be divided by the years to collect, like was originally set up. A meeting will have to be set up with the joint board for Warrington/Sugar Creek to request to extend the payments and to inform Allen that they are too late to get put on for collection on the 2020 tax bills collected in 2021.

Bob explained the purpose of the budget commission meeting with Pandora this afternoon.
