Norm is going to take the time to go out to the recycling building with Supervisor Joe Hohlbein after leaving our office for Joe to show him around. Joe & Norm left to go out to the recycling building. Commissioners Schroeder & Schlumbohm said it sounds like Norm would be a good help with the maintenance out at recycling. They also told Alaina to contact Jamie Zawilla again about grants, EPA or Workers Comp since she does great work for that.

Cindy let the commissioners know she didn't hear anything back from The Webbs at Serenity about the lift station. She said maybe one of you need to call them. Commissioner Schroeder will see if he has their phone number and try to contact them.

Commissioner Schroeder and Schlumbohm called Sherry and Jim Webb of Serenity Living to explain the costs of operating the pump station generator and maintenance on the pump station that the County is currently funding. Vince explained that the monthly maintenance costs will be forwarded on to Serenity starting in January 2023 at \$ 250.00 per month. The Webbs asked about the rent they receive from Pathways for the apartment. The County does not pay that, it comes directly from Pathways. It was asked about Serenity purchasing the pump station, some research will need to be done if that is possible and what a fair price would be. The Webbs said that they have purchased another home is Deshler so they have expanded their services. They have staffing issues just like everyone else.
