Bob Benroth stopped in to share with the Commissioners Schroeder and Schlumbohm the budget figures with a 2% increase. Bob also reviewed some of the other budget figures.

Commissioners Schroeder and Schlumbohm attended a Zoom meeting with Jason Hedrick, Norma Unverferth and Beth Scheckelhoff to discuss the 2021 OSU Extension budget. Jason provided a handout showing the highlights for the year. The budget request amount was reviewed item by item. The budget request is 1.2% increase from last year. Most of the programs were completed prior to the shutdown in March. Email and webinars have increased to continue the services. The 4-H program will be able to be face to face for 2021 with distancing. Jason reviewed the grants that have been awarded to the County and educational outreach programs in our County. The SHARP site tile has been replaced and the other farm programs were given a quick review. The Commissioners don't see a problem with the budget request. Commissioner Lammers joined the meeting via teleconference also. There are some programs already scheduled for 2021 and additional events are being added to accommodate the attendance limits. Commissioner Schroeder asked about the office conditions within the building. They still have 2 dehumidifiers running continuously. The floor covering was replaced which has helped with some of the moisture issues. Vince explained that there is a drain available for a drain hose to be run through a wall to the back section so they can be running on a more constant basis. Commissioners suggested that they contact Tim Schnipke for the drain upgrades.

The minutes from Thursday November 19, 2020 were reviewed and approved.
