Tim also talked about changing out the light fixtures in the courthouse all to LED fixtures to lower utility costs. Commissioners Schroeder asked what would be the most important project at the Jail, Tim said they both need to be addressed.

Joel Smith of Empower Retirement met with Commissioners Schroeder and Schlumbohm to discuss the CCAO Deferred Comp Program.
