Jeff Giesige met with Commissioners Schroeder and Schlumbohm and Commissioner Lammers via teleconference, to discuss another possible two stage ditch project located north of Leipsic. The possibility of a wet land project at the Landfill for the leachate treatment was discussed, it is still being reviewed by the EPA. Jeff explained that Bonnie Brooks at Soil & Water would like to do an educational program using the Landfill for identifying bugs and plants. Jeff said it could also be used as a pollination patch. The turbidity in the pond at the Landfill is cause for hesitation of the project. Jeff presented some ideas for the pond. He is hoping to get to use the Landfill for an educational site eventually. The Commissioners are hoping that the EPA would be willing to use our Landfill as an experimental project for the leachate treatment. Jeff already talked to Mike Lenhart Engineer regarding the ditch he is questioning for use as a two-stage ditch, which is north of Leipsic. This ditch is not currently on county ditch maintenance and the Commissioners would have to approve the ditch project. The ditch is located in Van Buren township starting at county line and Road 5 following south. The Commissioners are in favor of the project, Jeff had sent a resolution earlier this morning for review and submission for the agenda.
