Mr. Horstman thought the funds collected from selling the licenses was for damages to farm animals caused by wild dogs. The Commissioners will check into this and get back with Mr. Horstman.

Commissioners Schroeder, Schlumbohm and Lammers held discussions on -

Sewer Dist #2 repairs-Bockrath is doing the engineering for replacing the pumps with pumps that are used by the Village. IT was discussed about getting a local loan to fund the repairs on behalf of the sewer district. Bob Benroth joined the meeting and the Commissioners asked him about the options of local loan on behalf on the sewer district. The Village will not accept the debt of the sewer district. The Sewer district will be responsible for the debt. With the repairs the sewer district could get ahead on the funds. Bob said we can look into a local loan since the Commissioners have taxing authority and are a political subdivision. There are quotes available for the work from Kahle, Electric and Advanced Rehab. The pumps are acting up again and it is thought to be the electrical panels, which are also being replaced. Mr. Schlumbohm will get a time frame set up from the contractors and Bockrath. The terms of the loan to be inquired on are for \$100,000 for 10 years with the option to pay off early. Interest rates will be collected as well as any closing costs.

Leachate –wetland creation-Bockrath is working on this and it is pending an EPA approval.

Courthouse project- marble floor east entrance no addt'l already figured in- The Commissioners agreed with this.

Recycle Truck –needs work-The Commissioners agreed to get the truck fixed again at this time and may look into trading it in on a newer truck if possible.

Insurance bid-award bid-The Commissioners are reviewing the bids have agreed to award the bid to Fortman and UIS Insurance based on previous service.

Tower agreement –terms-Gary Lammers is drafting the agreement and it will be ready for next week.

CORSA meeting –Dec 4 who is attending- Vince will be attending the meeting as well as the winter conference.

Airport repairs-CORSA not covering- The Commissioners are aware that is will not be covered under CORSA, the mold remediation is completed and the repairs will be listed in a quote.
