Mr. Lammers called the meeting to order with Mr. Schroeder and Mr. Schlumbohm by reciting the Pledge of Allegiance.

Tim Schnipke stopped in to talk to the Commissioners Schroeder, Schlumbohm and Lammers. The Commissioners brought up the request from Nolan for the lower wattage lightbulb in the Engineer's office. Tim said all the lightbulbs in the building are the same wattage and are changed when needed. Tim said the new bulbs are set at the lowest setting for brightness also. Tim is meeting with Gary Hermiller at the fairgrounds tomorrow to get an estimate put together

for the drainage project. Tim also presented an estimate from Andy Schroeder for digging out the old cement at Recycling. The old railroad ties will go to the landfill. Tree and brush clearing will be included. There is a concern for supporting the back wall and drive due to the drop off and the hill. There is a footer and a broken tile in the area that will need to be taken care of during the project also. The Commissioners will review the estimate presented from Andy Schroeder, if they approve a purchase order will be done. Tim went to the HPS meeting in Michigan, he found a supplier where he can get heating and electrical supplies. Tim said we can get a 40% discount from Sherman-Williams paint through HPS also. Tim did talk to someone about materials for repairing the jail showers. He did get some ideas for working with the cement block walls and the moisture. Tim is looking into getting uniforms through Cintas for the maintenance guys. The heater is partial up at the Ag Complex.

Commissioners Schroeder, Schlumbohm and Lammers held discussion on the request received of adding the Council on Aging to the county's health insurance program. Melissa Bodey called to inform the Commissioners that she received a call from Council on Aging to be added to the County's health insurance program. It is the Commissioners' decision if they can be added. The Council on Aging has 20 people with 6 eligible for insurance and only 5 taking it. Putnam County would be the fiduciary. Adding them would not affect the rates or plan. Kim Nordhaus joined the meeting. She would need to do the input for the deductions and would need to receive a check from them each month. The Commissioners are not in favor of adding them to the insurance program, since they do not have any control over them. Also, the county does not prepare their payroll so they cannot be on the county's insurance program.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday October 18, 2022 were reviewed and approved.
