Tim Schnipke stopped in to give Commissioners an update on the storage at the Fairgrounds and moving the equipment that is infringing upon the EMS area. The fairboard would like to receive rent for the space that is used at the fairgrounds. Soil & Water's farm equipment will have to go somewhere else in a different area due to not fitting through the doors.

Mr. Lammers gave an update on the Airport meeting and that the Sheriff's office is raising the communication tower. Mr. Lammers also talked about the Airport needing some funds for maintaining the fuel farm, the revenue from the fuel farm goes into the Airport operations fund, so the operations fund can pay the expenses to improve the fuel farm.

Mr. Schlumbohm arrived at the office.

Mr. Schroeder gave an update on the CCAO meeting to Mr. Lammers and Mr. Schlumbohm. There was a motion to go into mitigation and an amendment to make it binding until the winter conference. It was too early for this to be resolved. Mr. Brownlee is still dismissed. This would not affect the Counties' CORSA insurance just their standing with the CCAO. CCAO wants to keep CORSA as an affiliate not as a separate entity. CORSA was started as an independent entity.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers, and Cindy Landwehr, Clerk.

Mike Klear met with Commissioners Schroeder, Schlumbohm and Lammers and Tim Schnipke to discuss storage space at the Ag Complex. Mr. Klear had questions about his equipment area in the Ag Complex there is a tractor and drill in his area. Mr. Klear said he will be getting more equipment (gator & generator) through a grant so he will need room for them. Mr. Klear is concerned about space for winter. The farm equipment needs to be moved out of EMS area. A larger door needs to be put in in the front but hasn't been done yet this year. The show arena at the fairgrounds is available for renting this year. Vince will talk to Soil & Water and Glen Arnold about moving their equipment.

The minutes from Thursday October 17, 2019 were reviewed and approved.

Sherri Britsch and Doris Schroeder of the Recorder's office met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the current situation in the Recorder's office. They are concerned over the constant questions and having to implement higher security due to the Recorder not able to perform her job duties. They are concerned over items that the Recorder does that they have to oversee to confirm it is done correctly and not lost. It is causing health issues with the staff due to the additional stress and causing constant interruptions to the work flow. They do not feel they are being productive and doing as well as they should having to keep track of the Recorders' actions in additional to their regular job duties. They do not think the taxpayers should be paying her if she cannot perform her job. The Commissioners will be contacting other organizations to seek assistance and guidance. They do not want any of these circumstances to go against her, they just want her to get the help and care she needs.

Vince had a call from Doug Royer of Equipment Relocation Company regarding some rental space at the Ag Complex. He is seeking 8,000 sq. ft. of space.
