Mr. Lammers called the meeting to order with Mr. Schroeder and Mr. Schlumbohm by reciting the Pledge of Allegiance.

Greg Luersman met with Commissioners Schroeder, Schlumbohm and Lammers regarding the Planning Commission and the need for it and possibly transferring the responsibility to another person within the Engineer's office and even including a person from the Recorder's office. The tax map position would need some assistance from the person from the Recorder's office to create a full-time position, which is currently a part-time position. The County also needs a certified Flood Plan Manager, since Denise retired from the Village. A written proposal will be presented from all the departments involved.

Tim asked about the wages for air unit work to be happening on several buildings. The work will be done with All-Temp Refrigeration (Adam) who has the State bid with State Term. They just wanted to make sure they were looking at the wages right versus what was bid. Tim explained each unit they are looking at Jail, Courthouse etc. The jail was built with a cookie cutter state design no matter the size or population rate. The units will be replaced with Carrier units.

Charlie Morman stopped in to talk to the Commissioners Schroeder, Schlumbohm and Lammers he said the army worms are bad with people wanting him to spray. The prices for grass seed went up. Charlie asked if there was any maintenance needing done at the Landfill. The Commissioners said nothing needs to be done currently.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

Alaina Siefker met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the County's wellness program. Alaina said CEBCO made some changes to the program for 2021-2022. The Commissioners can now pick what parts of the wellness program they want to have included for completing the program. The first section is the blood draw main requirements and whether to include spouses again in the gift cards for the blood draws. Commissioners said employees and spouses would be included in the \$50 wellness grant gas cards for getting the initial blood draw done. The extra challenges are in the section two now and points are going away. It will now be self-report just to mark if completed. The grant requires us to offer a minimum of items already so some of the items we will be offering anyways due to the grant funds like lunch & learns, water challenges and step challenges. The Commissioners asked what they need to do to complete the program. Local & community programs are required. They went with making 2 items mandatory in sections 2 & 3 for completing the whole wellness program. A new app will be available next year that will replace the Engage app. It will have your county health insurance info, card information with claim #, claims and also will have access to the wellness portal through there as well.

The minutes from Tuesday August 31, were reviewed and approved.

The minutes from Tuesday August 19, were reviewed and revised for clarity in the discussion regarding the ARP funds distribution to the fire departments.

August 19, 2021

"Gary brought up the ARP request for the new radios for the EMS/EMA, those radios could have been purchased through the E-911 funds rather than the ARP funds. Those ARP expense funds could be used for another purpose. The fire department are also refusing the E-911 funds due to the receipt of the ARP funds from the Commissioners. The E-911 funds are readily available and are specifically for these expenses where the ARP funds could be used for other needed expenses."

On September 2, 2021

Mr. Schroeder moved to amend the minutes to read as follows:

"Gary brought up the ARP request for the new radios for the EMS/EMA, those radios could have been purchased through the E-911 funds rather than the ARP funds. Those ARP expense funds could be used for another purpose. The fire department are declining the E-911 funds for purchasing radios due to the receipt of other funding sources. The E-911 funds are readily available and are specifically for these expenses where the ARP funds could be used for other needed expenses. The Fire departments would like E-911 funds for the user fees for the radios."

The correspondence received from the fire department and E-911 in response to the Aug 19 discussion will be added to the minutes also.
