Commissioners Schroeder called the meeting to order with Commissioners Schlumbohm and Lammers by reciting the Pledge of Allegiance.

Commissioner Lammers gave an update on the Airport Board wanting to redo the fuel farm at the Airport. The Airport board will need additional funding for the upgrade. The Airport board will be coming in in the spring to discuss with the Commissioners.

Commissioners Schroeder, Schlumbohm and Lammers met with Ashley Siefker and Tim Schnipke to discuss the rental rates for the Ag Complex warehouse space. All five renter leases were reviewed and new rates were discussed based on square footage and building improvements that were done in the last several months. Before finalizing rates and terms Tim will be getting with Tall Timers to evaluate the space they use and confirm boundaries of what they have available. Once complete Ashley will update leases to reflect necessary changes and get the approved and signed by all parties by the end of the year.

Tim Schnipke talked with Commissioners about the outside construction needed for the Recycling area. Tim got a quote from Andy Schroeder for the excavating work, tree removal, drainage and removing the rail spur. Commissioner Schlumbohm suggested holding off on the concrete work until spring since the new bailer won't be in until next year. Maybe gets better bids for it then also.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday September 20, 2022 were reviewed and approved.

Jim Schmitz met with Commissioners Schroeder, Schlumbohm and Lammers for a Recycling Interview.

Kevin Niese of Technicon Design Group met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the grandstand estimates. Kevin presented drawings from last year for a new structure of the same size, which would provide additional seating for 50, due to ADA compliance. The cost for a new structure is approx. \$2.6 million and refurbishing would be approx. \$1 million. Do the Commissioners want to go with new or rehab and start the construction now or later? Delaying the project would not create any cost savings on materials. The Commissioners are in favor to do construction now and would like to do the rehab rather than new. It could be substantially completed prior to the fair next year. The costs of the other new building have dropped slightly the timeframe for getting supplies is getting better there are still somethings that have a longer delivery time. New foundations are the critical phase of the grandstand rehab and accommodations can be made during cold weather for that work. Vince asked about the roof materials for the grandstand will it be re-sheeted? It is thought the roof was replaced about 30-40 years ago with new sheeting. The roof will be included with the rehab. The Commissioners want to get moving on the other building also. Kevin said they are finalizing the plans to get a firmer price for bidding in possibly January.
