Mike Klear and Brian Hilvers met with Commissioners Schroeder and Schlumbohm and Commissioner Lammers via teleconference to discuss EMS Personnel and Rescue Act Funding. Mike Klear brought up hiring the additional full-time 303 positions he said that has worked out well. He said they will need to hire two more additional full-time positions. There were two additional bedrooms added to the house for the additional people on call. On-call is a voluntary position. The volunteer force is dwindling. The starting pay may need to be bumped up to retain employees and entice new employees. Mr. Hilvers suggested paying employees per run rather than per hour. Average time of a run is 2.5 hours he suggested and the amount would be the same no matter how long the run would take or until a sign off. The pay per run would be based on their position; medic, EMT, or basic. The Commissioners suggested checking with the surrounding counties to see how they are staffed and paid. Volunteer training is paid. Mr. Klear wanted to get those positions filled as soon as possible. It would be an additional \$80,000 per year. The EMS budget can support that increase. The solar farm operation will give a boost to the EMS funds also. If there is adequate staffing then the runs from Ambulatory Care can be done which is certain income. Brian will be appointed to the position of EMS Director when Mike Klear is retiring as of Dec 27, 2021. Applications will be accepted to replace Brian and to fill the two new full-time medic positions. If using the pay per run a limit of how many can go on the run will be implemented. Regarding the ARP funding the Haz-mat Team will also need new SCBA units, the units they have used ones that came from Phillips. The ARP funding cannot be used to purchase replacement equipment only new additional equipment. Those purchases may be held off until more direction comes in from the Office of Budget Management. An addition of new living quarters with bays was brought up for EMS and that would provide a place for exposed or infected EMS staff to quarantine away from their families. Drive-through bays would be included to provide a vaccination site also. The need for individual bedrooms was discussed. The Commissioners explained some other options for drive-through sites.

Board of Elections members Kurt Sahloff, Tony Schroeder, Carla Tooman and Kathy Miller via teleconference along with Tess Elsoff from the Ohio Secretary of State met with Commissioners Schroeder and Schlumbohm and Mike Lammers via teleconference to discuss the Federal Labor Standards Act and comp time & employee compensation. A letter from the Prosecutor and Commissioners was received in July regarding the FLSA comp time & employee compensation. The Board of Elections feel their employees are eligible for the extra hours to earn comp time, which they would be exempt. BOE employees are not in administrative or supervisory positions. A resolution from the BOE was requested stating that the employees are not in supervisory roles. Some additional staff may be needed, which would be filled by using senior poll workers. There should be no impact to the budget. The States will remain in charge of the Board of Elections. Kurt brought up employee compensation. Introductions were made of Tess Elsoff to the Commissioners.

Mr. Schlumbohm moved to go into executive session to discuss employee compensation of Board of Elections employees with Mr. Sahloff, Mr. Schroeder and Mrs. Tooman, Commissioners Schroeder and Commissioner Lammers via teleconference

Commissioners went back on record. No decisions were made.

Tony Schroeder explained some of the representative redistricting for Ohio.

The business agenda was held with Commissioners Schroeder and Schlumbohm, Cindy Landwehr, Clerk and Commissioner Lammers listened via teleconference.

Chad Niese stopped in to talk to the Commissioners about Sergeant Major, Justin Lahew, Navy Seal from Columbus Grove and his presentation coming up in October. Judge Niese would like to request a proclamation from the Commissioners to present to Justin Lahew and setting October 16 as Justin Lahew Day within the County. Mr. Lahew is a recipient of the Navy Cross. Judge Niese also requested adding him to the Veteran Medal board within the Courthouse.

The minutes from Thursday September 16, 2021 were reviewed and approved.

Commissioners Schroeder and Schlumbohm attended a Board of Revision meeting.

Jeff Schroeder and Mark Hoorman met with Commissioners Schroeder and Schlumbohm and Commissioner Lammers via teleconference to discuss the fairgrounds/committee and items wanted for fairgrounds. Jeff and Mark met with Fair Board members and a few others regarding building one large fair show building for all animal species. They are looking at placement for the new building on the fairgrounds. The options of moving the fairgrounds location was presented. Even tearing down all the existing buildings and putting up a new building in that location. Also putting the new Junior fair and merchant building next to it. Purchasing more ground and moving the fair to set up an entertainment venue. Keeping the historical buildings was discussed if the additional land is purchased. There is an individual Matt Hughes who can be hired that can raise funds for the fairgrounds improvements. They want to create a larger venue where overnight accommodations could come in and then cater to the animal agriculture of the area to show animals year round and host shows as well. Jeff proposed it as a joint venture along with the fund raising to have a capital campaign to fund both buildings. Leasing the new land through a 501c 3 organization was also proposed to lower the building costs. Henry County earmarked \$50,000 per year to the Ag Society. Making the race track small was questioned. How shall they proceed? Are the Commissioners interested in purchasing additional ground? Could they trade properties? There is a retainer fee to hire Matt Hughes of \$13,000.00 to provide a leadership assessment. The Village may have to be brought in to the project also. The interest in expanding across the road will be looked at, then the Commissioners can meet with Matt Hughes.
