Commissioners Schlumbohm called a sewer district #2 resident about the work that was done near his property since he has water pooling, the resident was referred to the Engineer's office

Sheriff Siefker, Staci Schroeder, Brandi Schroeder, Brad Nelson and Todd Worchuck and met with Commissioners Schroeder and Schlumbohm to discuss union contract negotiations. Staci said they would be discussing wages.

Commissioners went back on record, no decisions were made.

The business agenda was held with Commissioners Schroeder and Schlumbohm and Cindy Landwehr, Clerk.

The minutes from Thursday August 22, 2024 were reviewed and approved.

Commissioners Schroeder and Schlumbohm attended a landbank board meeting.

Jeff Reinkemeyer & Dylan Borchers met with Commissioners Schroeder & Schlumbohm, Greg Luersman Kyle Nemire, Gary Lammers, Martin Kuhlman and Bob Benroth to discuss the payments. New staff for Avangrid were introduced Sheena Christian, Shawn Haley and Lucas McCoy.

Bob Benroth stated that the fence border determines the taxing border. The payment with Blue Harvest were explained and used as an example. The project are under Ohio Air Quality.

Blue Harvest signed comp agmt in May of 2022 for \$9,000 PILOT pymt

Oct signed QAP application, so Jan it was still bare farm ground. QAP cert issue in Jan of 2024. The bond was received in July of 2023 fall of 2023 construction completion. As of Jan 1 of 2024 there will be taxation starting for them.

Powell Ck agmt was signed in 2020, Sept of 2021 comp agrmt signed bond cert in Dec of 2022 construction started in fall of 2023.

As of Jan 1 of 2024 CAUV no longer qualifies. How should it be taxed is it commercial or agricultural? A meeting with the Commissioners helped to determine the PILOT is not paid until energy is produced. Jan 1 it is no longer agricultural but due to the timing of the construction there is gap in the land use. How will the payments be handled will they be under the QAP program? If we are in agreement that some form of revenue needs to come from the properties during construction period. A supplemental payment in lieu of taxes can be set up for the construction period. Would this gualify under state law for taxation? The property is exempt since th bond is outstanding. Avangrid wants to make sure the county gets revenue during the construction phase. What the payment will be must be determined. The Auditor can contact the dept. of taxation to see what they can collect. The outstanding taxes will be figured. Outside the fence the landowners is responsible for. Inside the fence Avangrid is responsible for. All but one farmer will continue farming outside the fence. The acreage inside the fence must be determined to determine the payment. The landowners would be billed for the outside fence portion and Avangrid will make the inside portion on the exempt land if it is commercial. What was the intent at the time of agreement? Most outside properties will still qualify for CAUV. There is no recoupment on this. What is the value of the inside the fence construction PILOT? The values must be compared to determine payments. It is 900 acres roughly but a more certain number will be verified. Each landowner's portion must be reviewed to determine amounts for commercial versus farm land. A valuation must be determined due to the timeframe of construction. Some flexibility is needed. The Dept. of Taxation must give input to help determine taxing authority for commercial versus agricultural rates. The auditor can make the determination. Bob reviewed Taxation instructions for certification. They want to be fair to everybody that why we are here today. Other state projects were discussed. This is the first Air Quality project. A letter will not be received for notice of operation yet. Substantial completion will not be until next year. The taxation is base on Jan 1 date. Th Construction PILOT for Blue Harvest is for two years. The fence line boundary must be provided and the rates for CAUV for

the properties so the payment amounts can be determined. These amounts will be needed for the landowners anyway. Two new taxing districts have been created for these payments when the energy is created, since it crosses township lines. Percentages will have to be determined for actual figures will be based capacity of 150 megawatt. This will be figured parcel by parcel. Avangrid will provide the information that was requested. The taxing district info will be provided as a GIS overlay. The Van Wert project has not broken ground yet but is projected to soon. Preseeding of the site was discussed and looks good and has helped to minimize weeds.

These figures will be needed before the abstract is done for the taxation year. Site plans can be compared to the as-built plans for confirmation. The information can be submitted as an excel spreadsheet.

It is time this is figured and confirmed. Other items need to be addressed by Avangrid also.
