Commissioner Lammers left for the day.

Brian Hilvers met with Commissioners Schroeder and Schlumbohm to discuss the wages for ambulette drivers. Brian would like to increase the starting pay for his ambulette drivers since he is losing them other better paying jobs. They are short on drivers and he has had to turn down requests for riders. Some fees are reimbursed through insurance, Medicare or Medicaid. There are also "find a ride services" for doctor's appointments, running errands due to not having family members available to drive them. The find a ride service is self-supporting. All the drivers are part time and do not get benefits. He is looking to increase the starting pay to \$11.50 from \$11.00. And the experienced driver will get an increase also. This is an EMS expense not a county expense. Some of the transports may have to be cancelled due to not having enough drivers. The nursing homes within the county only have one van each and if it is already booked out it is not available to transports these people. The Commissioners are ok with the increase.

The Commissioners asked about the lease agreement for space with Kalida. Gary is reviewing and it will get forwarded to the Commissioners for their approval.

The new EMS building design was discussed, in regard to adding a day care area also for employee's children. The Commissioners said it would be a loss unless there are at least 60 children enrolled. There would not be that many children enrolled.

Tim Schnipke called in and talked to Commissioners Schroeder and Schlumbohm about an estimate that was sent to him for the lettering for the grandstands. He asked what they wanted for the wording and the commissioners said they want it to say Putnam County Fairgrounds. They gave a quote for stainless steel and an aluminum one with powder coated green. The commissioners said they would like Buckeye Custom Fab's opinion on which is better; whichever one the paint will stick to the best. Tim will contact them and check.

Commissioners Schroeder and Schlumbohm attended a teleconference with Allen, Van Wert, Auglaize and Mercer counties to discuss joint county ditch maintenance collections.
