Commissioners Schroeder Schlumbohm and Commissioners-elect Wehri and Brubaker attended the December Elected Officials meeting hosted by Sheriff Siefker.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk. Tim Wehri and Brad Brubaker joined the agenda.

The minutes from Tuesday, November 26, 2024 were reviewed and approved.

Hugh Downer of Eagon & Assoc. held a teleconference with Michelle Torres from Bowser Morner and Commissioners Schroeder, Schlumbohm and Lammers to discuss potential pilot test for ceasing leachate. Tim Wehri and Brad Brubaker were in on the meeting. Hugh said that during a ground water inspection performed during the 2024 second semiannual ground water sampling event in September 2024, the Ohio EPA review was also held by Ken Brock. Ken had indicated the potential for Ohio EPA concurrence with a pilot test that would suspend leachate hauling at the site. Ken referred to two sites that he deals with that and making a case for collection cessation. The post-closure care period for the site ends in April 2032. Verbally Ken indicated to him that a request would require the inclusion of leachate quality and quantity data. Commissioner Schlumbohm asked do you cap off tank or how do you actually stop pumping. Hugh said we want to keep the water underground. The commissioners said we could take the first step with the pilot testing. Hugh said he would do up a letter to the EPA with review from Hugh, Michelle with Bowser Morner and the commissioners to state what we want to do with ceasing the pumping and doing the pilot testing. Hugh said he wanted to get this phone call started and will see if he can budget this into the current monitoring contract so we might not see any additional fee for it. He will let us know. He said he will start working on a draft in early 2025, then everyone will review and discuss; once okayed by everyone, then will submit to EPA.
