Commissioners Wehri, Schlumbohm and Brubaker attended the Elected Officials meeting hosted by Bob Benroth in the Lunch Room.

Commissioner Wehri called the meeting to order with Commissioners Brubaker and Schlumbohm and staff with the Pledge of Allegiance.

The business agenda was held with Commissioners Wehri, Schlumbohm and Brubaker and Cindy Landwehr, Clerk.

The minutes from Thursday, January 30, 2025 were reviewed and approved.

Riley Township trustees Mark Kinsinger, Joe Karhoff, Dan Karhoff, Matt Karhoff, Keith Sunderhaus, Greg Amstutz, and Gary Lammers, Bob Benroth, Mike Lenhart, Rob Fawcett met with Commissioners Wehri, Schlumbohm and Brubaker to discuss the Road M-6 Bridge. The start of this conversation was that there was camera footage of people misusing the bridge so it was closed for safety purposes. The bridge had been restored but was not reinforced. The components are still original from 1876. The components that had deteriorated were replaced with new material. The other bridges in the area have been replaced so the detour issues are over. Joe Karhoff is asking that the bridge be reopened is it structurally sound for a 5-ton limit. Why is this bridge still closed? Other bridges across the county are not policed. Road 7-L always snows shut each winter so this bridge is the only way to get through. There is nothing wrong with this bridge so why is it shut down? They would like to have a discussion to get to a resolution to use the bridge. Rob was questioned on the liability of the bridge; this bridge is insured by the county. As long as the bridge has not failed an inspection it can be reopened. The county's policy will cover damages. It is a physical damage policy. Since this bridge is closed the other bridges are getting abused. Commissioner Schlumbohm suggested lowering the limit to four-ton limit and reopening. Mr. Lenhart says since the bridge looks new the load limit signs were ignored. During galvanizing some of the parts were deteriorated more but

painted to look good. This is a historical bridge in the state program that is how it qualified for state funded restoration. This is a posted bridge similar to others within the county. It was voted to closed the bridge for pedestrian use only to preserve the bridge for historical value. Does this bridge need to be inspected for it be reopened? The load rating has already been set. The inspection on the integrity of the bridge has not been done. This bridge takes extra training to test the integrity as do other bridges in the county. Lenhart had the date that the bridge was being mis-used and overloaded. The Riley trustees were not in favor to close the bridge but were in favor to keeping it safe to use by reducing the load limit. Leaving the bridge limit at 5 ton was discussed to reopen. Those who misuse the bridge should be ticketed to be an example. There was more traffic due to the Road O and Road 6 bridges having work done, which is why this bridge was closed at the time. The taxpayers spent \$625,000 to restore this bridge. This road is access for the local residents to have emergency services. A dead-end road had been created and there are more issues with that now. Commissioner Wehri is not opposed to reopening it. More signage would be needed and reassigning it to a 4-ton load limit. It was recommended to look at it again before an official decision is made.

Mr. Schlumbohm moved to reopen the bridge at a 4-ton limit with the Engineer's approval of at least a 4-ton limit also.

There is camera surveillance on the bridge which has helped to eliminate some vandalism. What would happen if the bridge would fall in? Over time with wear and tear the bridge will collapse which is not covered by insurance. Could the bridge eventually be replaced? An electric Amazon truck could weigh at least 9,500 lbs. The bridge could not be turned over to the township it would still be under the county's maintenance. The decision of the commissioners is appreciated.

Mr. Lenhart wanted the Commissioners to know that someone will drive across this bridge over weight no matter how many signs are posted. The bridge was not reinforced when it was restored.

Mr. Wehri moved to adjourn for lunch.

Commissioners resumed session.

Commissioners Wehri, Schlumbohm and Brubaker attended the joint county ditch video conference call on West Jennings Creek Ditch with Allen & Van Wert Counties to discuss the change order #2 for log jam & sandbar removal. Once they started getting some of the log jams out and the water went down, the ditch was in a lot worse shape than they thought. They are very happy with the great work that the contractor did out there and work was done early January. Van Wert County Commissioner Thad Lichtensteiger ran the meeting and their clerk, Ryanne Bollenbacher, took the motions and votes.

Commissioner Schlumbohm left for the day at 2:00pm
