Tim Schnipke came in to update the Commissioners on the facility summit he attended yesterday. He recommended talking to County Firm for the project management services. Tim got some info how other counties handle their maintenance issues. He is working on getting more contacts of the surrounding counties maintenance staff. Tim brought up the backflow testing and the valves that get replaced when the testing is not passed.

Commissioner Schlumbohm led the staff and other Commissioners in reciting the Pledge of Allegiance.

Tim said there is a maintenance truck that could be available to trade to the Fairgrounds, and purchase a new truck for maintenance. Commissioner Brubaker said he was contacted by a fleet management service who he invited in to come and talk about services. There may be a couple of dump trucks coming from the Engineer that could be a good trade to another department also. Tim said they will be working at the event center today to repair the doors again. The garbage disposal still leaks and has since installation. A new disposal is needed. If it

is not replaced by March maintenance can buy a new one and install it and charge it to Helms. This is the fourth set of doors to be installed. The shiplap is coming loose because it is drying in the building hopefully the insulation is drying also. Different types of building insulation was discussed.

Nolan Croy met with Commissioners Wehri, Schlumbohm and Brubaker to discuss planning commission members. Active board members help to make things run smoother. A meeting is scheduled for next week. Some of the members are not available to attend, but there should be a quorum. Beth Skulina with the Health Dept is currently on the planning commission and she is turning that over to the new person, Dave Amormino. He would need to be appointed to the Planning Commission by the Commissioners. Vince Schroeder has expressed interest in being on the Planning Commission also. There is no set membership for the planning commission. There are three trustees on the planning commission currently.

Ryan Moran submitted some ditch plans for the new Commissioners to review prior to the hearing this morning since they were not here for the first hearing.

The business agenda was held with Commissioners Wehri, Schlumbohm and Brubaker and Cindy Landwehr, Clerk.

The minutes from Tuesday February 4, 2025 were reviewed and approved.

Brian Hilvers came in to ask about setting up a committee for the construction of the new EMS building addition. The Commissioners said yes go ahead and put together a construction committee.
