Mr. Brubaker opened the meeting with leading the Pledge of Allegiance with Commissioners Schlumbohm and Wehri, Cindy Landwehr and Alaina Siefker.

Commissioners Brubaker, Schlumbohm and Wehri held a discussion on Judge Borer's budget request from last Tuesday. The Commissioners did agree with the fact that the Judge does need to hire an additional probation officer. As for the technology updates those can be decided when the outcome of the grant request is known. Putting all the courts in the same software (Courtview) would make sense, the cost would have to be reviewed. The judge requested \$51,000 total for all his needs; juvenile was \$42,000 probate was \$9,000.

JFS Director John Folk met with Commissioners Brubaker, Schlumbohm and Wehri to discuss agency updates.

Mr. Schlumbohm moved to go into executive session with Commissioners Brubaker and Wehri and John Folk to discuss employee compensation and employee appointments

The Commissioners went back on record at 9:39am, no decisions were made.

Mr. Folk had a question about a family services planning committee. This plan can be developed by a committee or by advertising. There are services available through the Family and Children First Council and he can consult with them to see what is available and gather the information needed to complete the plan. Mr. Folk brought up the auction. There is a storage unit that contains equipment and tools for the work program. The work program is not currently active. Does the work program need to be reactivated is it needed in the community? Should he keep the tools and equipment or put it on the auction? The work program is for the people who get assistance and must have work hours to qualify for that assistance. There is no funding for the work program currently. The Workforce Investment program must change on the state level, there is a youth work program that is funded. CCMEP provides the funding for a youth work program. They could work with the schools and assist them with the summer help they need. This program helps the kids to get job experience and build a resume. The kids that are in the program will be compensated and evaluated and could be removed from the program if they are not performing at the job. Mr. Folk would like to build the program here if there is need for it. Mr. Folk may clean out the storage unit and if some other county offices can use the items, they will have an opportunity to acquire these items through the auction prep process. This will hopefully eliminate the additional cost of rental the storage unit. Commissioner Brubaker asked for a list of vehicles and fuel usage report for each vehicle from JFS. The Ohio Means Jobs is asking about hours of work and office use while the JFS is not open. For Fridays there is an issue since the agency closes at noon on Fridays. They could move to a different county. As long as the agency is open they have access to office space.

The business agenda was held with Commissioners Schlumbohm, Wehri, and Brubaker, and Cindy Landwehr, Clerk.

The minutes from Thursday, March 13, 2025 were reviewed and approved.

Chris Sosebee and Jacob Deible of Weigand Construction stopped in to ask the Commissioners some questions about the RFP submission. They are asking how the Commissioners want the responses. Is there any more information that can be shared regarding the RFP? The Commissioners are learning as they go with this process. And Technicon Design Group can be consulted. The schedule can be submitted and the Commissioners will consider with the price. There is no deadline date for funding for the project. Weigand is also working with Technicon Design Group for their own project.

Tim Schnipke stopped in to update the Commissioners that there are people working at the Event Center. A proposal for the remediation of the Event Center's wet insulation has not been submitted yet. The Commissioners informed Tim of the cleaning out of the JFS storage unit. The storage in the garage at O-G road is from Home Health & Hospice.

Commissioners Brubaker, Schlumbohm and Wehri went to review the Annex building for a security assessment.
