Tim Schnipke stopped in to talk to the Commissioners about the location of the auction. For this year the auction can be held in the Ag Complex, there is space inside the warehouse and it will be cleared in time for the auction. There is room for parking also. Signage will be needed to

notify people of the change in location. There is a power broom to sweep the building after the auction. The Sheriff's office is almost done with the flooring, things are moving along. The paint bill was received and the painting was done well. Tim is still waiting on a quote for painting in the courtroom. JB Net looked at the doors at the Annex and submitted a quote still waiting on a quote from Leever Glass. The spraying will be done at the landfill within the next week. The quotes for the door controls at the Sheriff's office are being reviewed and see if that cost can be split between this year and next year.

Commissioners Wehri and Schlumbohm held a public hearing for the alley vacation in Rushmore, Ohio. Two neighboring landowners attended the hearing. The survey and legal description were reviewed. The neighbor to the east was concerned about the proximity of the new property line to her house. Typically, the alley would be divided 50/50 when it is vacated. There are trees in the area in question. The alley is currently a 12 ft width. Mrs. Zendejas would like to know if she is getting 6 ft. from the alley. She does maintain the area in question. They do not know all the plans of those who made the request if they will be installing a fence.
