Maintenance Supervisor Tim Schnipke came in to let the commissioners know that he got some quotes for some plaster work in the courthouse. He has another quote coming in on Wednesday. Wednesday night the Ag Complex sprinkler compressor went out so he got a quote for a new fire rated one for \$2,650 and they will install. The commissioners had Tim look into changing the alarm system at the Glandorf Building to Lima Security Alarm System, upgrading the system to cellular based, & keeping the systems separate for different parts of the building with a price about \$15-16,000. Tim will need a letter from the Glandorf Fire Chief and he will contact them. Water meter in courthouse is dead and since commercial they want us to purchase it.

Commissioners Wehri, Schlumbohm and Brubaker held a discussion on the retire/rehire policy. Commissioner Brubaker said the union did vote and approve the memorandum. Commissioner Schlumbohm said they will need to rescind the current resolution #0335 dated June 17, 2014 for the retire/rehire policy and will need to do a new one that they will add the MOU union parameters in on a new resolution along with parameters for county employees not in the union.
