Tim Schnipke stopped in to give Commissioners Schlumbohm and Brubaker maintenance updates and vehicles updates. The dairy barn wiring at the fairgrounds is almost done, the goat and sheep barn is not complete they are waiting on other construction to be completed. The Commissioners shared with Tim the findings of their security tour at the Annex. They were thinking about adding another door and a security feature to buzz people through the new door. The option for the ground floor would be to have everyone use the elevator to enter and still have the elevator for egress. The windows need to be replaced in the Annex. The back door of the Annex needs a crash bar. There are not L-shaped steel pieces around the windows just flat steel pieces that are bowing under the weight. The second floor, flooring was thought to be the old gym floor. Tim will look into adding the panic bars, updating the windows and outdoor lighting.

Kathy Kaufman and Ruth Carter Crist with the Putnam County Re-entry Coalition met with Commissioners, Wehri, Schlumbohm and Brubaker to give them some updates, ask for support and on grants with Ohio Department of Rehabilitation & Corrections. They are in year two of a two year grant through the ODRC, which helps to integrate people who have been incarcerated back into society. Rehabilitating people back into society is hard, most do not have family to go back home to. Kathy was incarcerated for three years. It is hard being incarcerated but it is harder to come out. There are no rehab houses in Putnam County. There are issues with mental health, those who have been arrested as a teenager have not mentally developed beyond that age. They have not had anyone to help them along and help them make better decisions. It is difficult to get them housing and jobs. There are not as many coming back to Putnam County as there are in other larger counties. Most do not have a current drivers license so they would not have a car, no transportation or insurance. There are homeless in Putnam County. There are some local vendors who are helping with the coalition, in providing services to these people to get them some help. They do work with Henry County as they have a substance abuse home. The Putnam Sheriff's office and Job & Family Services have been helpful. They would like one of the Commissioners to join their board. The coalition is organizing information for the released people to get services and help to live on their own. Immediate needs are recognized first, food and shelter. This is a community problem so they get community aid for these people. Kathy did have her dad as her advocate while she was incarcerated. Most people do not have that and do not have anyone that is willing to help them to get the services and medical care that is needed for them while incarcerated. A proclamation was presented for the Commissioners to adopt for second chance month in April. They are working on setting up a funding stream for the services they provide. They would like to organize with some of the civic organizations within the county to help get the word out and create services. This would help to provide transportation for individuals to report to their parole officers. Kathy learned her business skills of dog training and grooming while incarcerated. She now owns her own business and employs 7 full time and 7 part time employees. She looks at someone for who they are at that moment not what they had done in the past. Treat everyone with respect. They are getting the word out have been meeting different organizations, attending workshops and had an article on the front page of the Sentinel. They are notified when someone is coming out the system as well as referrals from Job & Family. Kathy explained her service dog that she brought along and how she visits at the nursing home with the dogs. There are more services available in the cities and there is no public transportation here. Kathy and Ruth are volunteering their time they do not get compensated.

The business agenda was held with Commissioners Schlumbohm, Wehri, and Brubaker, and Cindy Landwehr, Clerk.

Mike Lenhart stopped in to update the Commissioners on the Hermiller Dt project, that the tile that is being used is not perforated and there is water in the ditch. The tile should be perforated to get the existing water into the tile to drain away. The landowners need to be ok with installing perforated tile rather than solid tile.

Treasurer Tracy Warnecke and Kim Redman met with Commissioners Schlumbohm, Wehri, and Brubaker for an Investment Meeting.

The minutes from Tuesday, March 25, 2025 were reviewed and approved.

Commissioner Schlumbohm contacted the residents from Sewer District #1 that have not responded to the request for their information regarding the water meter installations.
