Brian Hilvers was called in to meet with Commissioners Schroeder, Schlumbohm and Lammers to discuss a new building and new west side location for the EMS. Brad Brubaker attended the meeting. The old NAPA store in Kalida may be an option for a squad location on the west side of the county. This could be a manned squad during the day. Transports could be done be them also. Cost estimates were requested for the operations. This could cut down response time for an incident on that side of the county. The NAPA building could have the accommodations

needed for day staff and a bay area for a squad. The house is overcrowded and some of this staff could be relocated to the Kalida site. A new building is at least two years out. West side squads have good attendance for responding to calls. The issues are with Leipsic, Pandora, and Ottawa, having staff to respond. The volunteer push is getting some not many new people, but the same people are continuing to make more runs. The added entry to the house could be delayed if the house is not going to be kept. A squad staff could be set in the Kalida Fire station. There is a room for day staff since Kalida has a new administrative building. This would not be 24 -7, it would be 8-10 hours per day. Estimates will be collected by Mr. Hilvers for these operations, to see the cost effectiveness. Plans for a new building can be requested from an architect. Some prospective plan ideas for a new building were reviewed.

An investment meeting was held with Commissioners Schroeder, Schlumbohm and Lammers, Tracy Warnecke and Kim Redman. Brad Brubaker sat in on the meeting.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers, And Cindy Landwehr, Clerk. Brad Brubaker attended the meeting.

The minutes from Tuesday June 25, 2024 were reviewed and approved.

Tim Schnipke and Aaron Vorst met with Commissioners Schroeder, Schlumbohm and Lammers to discuss repairs to the Annex roof. Brad Brubaker sat in on the meeting. Tim had photos of the condition of the roof and informed the Commissioners of the current situation with buckets that need emptied after each rain. Tim has a quote from Damschroeder through TIPS for a new Durolast replacement roof. The roof had been patched and repaired many times. Damschroeder is very detail oriented with the work they do. This project will be done in phases, so the shingles will be done separately. The completely bid is not ready more info is being gathered.

Commissioners Schroeder, Schlumbohm and Lammers and Mike Lenhart held a bid opening for the OPWC Paving. Barry Rosebrock and Brad Brubaker attended the bid opening. A bid was received from Ward Construction with bond included
