Amy Sealts met with Commissioners Wehri, Schlumbohm and Brubaker via teleconference to discuss a Cooperative Agreement with Toledo-Lucas County Port Authority. The agreement

would enable Putnam County to work with Toledo Port Authority on projects and allow them to perform on behalf of the County. Amy will get clarification on the 50% fee income for any conduit bond project. There are agreements that village have with Toledo Port Authority for energy districts. Due to new guidelines for port authorities, they must have permission from County Boards of Commissioners to act of their behalf. There are multiple counties that have Port Authorities that have agreements with Toledo Port Authority. Due to the new policies this agreement would prevent other large port authorities to come in and rule out local beneficiaries. Amy will contact the Prosecutor to address his questions as well.

Brian Hilvers and Scott Deitering stopped into talk to the Commissioners about replacing the motor in the Cols Grove squad. There are some options for replacing the engines. The cab may have to come off for the replacement. The quotes have a big difference in price based on the whether or not the cab must come off. Reineke's quote is higher but will include the extra work. August & Kuhlman's quotes may not include the extra work. They may just be giving a quote out of a book and not including the extra work that may be involved. August is contacting Braun to confirm what work will be needed. The engine repair will be held until the quotes are confirmed. Three quotes will be received. Brian is watching a power cot on gov deals and will be bidding on it, he had a limit not to exceed.
