Commissioners Schlumbohm, and Wehri, Engineer Mike Lenhart, & Alaina Siefker had a zoom meeting with Jeff Giesige & Curtis Tobe from Soil & Water & Michelle Torres & Patrick Loper with Bowser Morner to discuss the landfill sampling, landfill ponds and the US EPA Inspection Report Review & Options. Michelle went over the comments the US EPA had on the report. She said currently our NPDES requires a SWPPP and that north end pond and area is not included. Jeff Giesige said his proposal was to turn the large pond and pond area to north of building into wetlands through the H2O grants. He is unsure where the confusion is coming from between the EPA on the changes when the person he had been dealing with was ok with all the changes they requested. She said we do need to get some of the erosion areas to the north of the building planted with some vegetation. Looking at doing work in small pond and moving outfall just a tad south. She will also do a proposal on adding the north pond to the SWPPP for the NPDES permit and we will most likely need to monitor it Commissioner Brubaker joined the meeting. Mike Lenhart said he could berm up some ground around the area they use out there. He could do a vegetative filter strip 600-650 feet with rock at the beginning and could do a straw blanket. Michelle will prepare a response on all the items and send it over to the commissioners to review on Thursday so she can get it sent out within the 30 days. We do realize additional cost will be for Bowser to monitor two spots instead of one.
