Commissioners Wehri, Schlumbohm & Brubaker had a phone call with Michelle Torres from Bowser Morner and said they reviewed the response she prepared for the EPA. Commissioner Schlumbohm mentioned he thought adding the map she showed during the meeting the other day would be great to add to the submittal and making notes on it for what we are proposing and labeling everything. Maybe with the visuals that would help for everyone to understand what is being requested. She will send to us for review again after she makes those updates.

Tim Schnipke stopped in to show the Commissioners photos of the water leak that was found at the Ag Complex. There were some rotten pieces and bolts that were replaced. There are more spots that have the same materials that will be checked. There are lines that are no longer used and may need to be removed. Tim said a catch basin will be added in the back next to Recycling. He will get a price and get it in before winter. The backhoe needs repairs also. Commissioner Brubaker talked to Kim at the Health Dept about some of their wishes for remodeling. He told her some of the smaller items can be done they would not be getting a window in the hallway. Tim said Schimmoeller Con. will level out the parking areas at the Health Dept to comply with ADA. The Board of Elections will be using the Event Center so those parking improvements must be done also. Tim asked about going to Kalida Truck for their open house which his today. The seal coating is all done on all the parking lots. The Commissioners asked about cracks, not all the cracks were filled completely. Tim will talk to the Engineer about

what they use. The lots are done every three years. Tim will talk to another sealing company next time.

Commissioners Wehri, Schlumbohm and Brubaker attended the informational meeting for the Lester Glasser Ditch #350 in the Assembly Room.

The business agenda was held with Commissioners Wehri, Schlumbohm & Brubaker and Cindy Landwehr, Clerk.

Commissioners Wehri, Schlumbohm and Brubaker met with Barb Diemer in regards to the Board of Elections. Barb made her introductions to the Commissioners. Barb had heard that the Board of Elections is not being run properly. Barb had heard that two people were fired from the Board of Elections. She had requested the current staff at the Board of Elections and their party affiliation and has not received that request. The Board of Commissioners is not over the Board of Elections. Barb was told to contact the Secretary of State or go to a Board of Elections meeting to get the information she is seeking. Barb explained some past situations where she had with local lawyers and her divorce, where she did not receive any alimony. She was a school bus driver, worked at Walmart, and Brookhill. She had attended the records meetings and no longer has due to the meetings now being held online. The Board of Elections does come in to meet with the Commissioners but they have not asked for any extra money this year. The budget meetings will be coming up. The departments get their allocation of money and the Commissioners do not govern how it is dispersed as compensation to the employees, they do give a recommendation. Barb has written correspondence to Donald Trump and JD Vance. She brought up Charlie Kirk. Barb has had many attorneys, she is on number seven. She was glad to meet the new Commissioners. Barb said the Meadows will no longer hire her to sing and play guitar there. She donated purses for their bingo prizes. Barb had broken her leg last year and had to spend a month at the Meadows for rehab. Barb wrote a book and has not been published vet.
