Commissioners Wehri, Schlumbohm and Brubaker went to the Putnam County Community Corrections Planning Board meeting in Common Pleas Courtroom.

Tim Schnipke stopped in to ask about SD #2 and the timeline of turning it over to Ottawa. He also asked about removing the trees at the EMS house lot. He said they will start removing them tomorrow. Touchstone wants to do a walk-through tomorrow. The windows for the Annex are ordered, along with gaskets. Tim is getting prices for a new transducer for SD #1 pump station; he has a quote for \$4,000. Is there a deadline for the stones at the landfill? We don't have a deadline yet until Bowser does the response back to the US EPA on timeline and estimate. The courtroom renovations will be starting in the next few weeks.

The business agenda was held with Commissioners Schlumbohm, Wehri, and Brubaker, and Cindy Landwehr, Clerk.

JFS Director, John Folk met with Commissioners Wehri, Schlumbohm and Brubaker to discuss Job & Family Services updates. The Commissioners enjoyed the picnic that was held on Sept 26. At this time all agency openings are filled. The wage and hiring plan is all in place. Everyone knows where they stand now. They are currently working on employee evaluations. There are a couple new initiatives for children services. Care portal is new. Churches, organizations and communities can contribute to help find things that are needed for child care. Connect to families is another initiative to find genealogy connections for helping find blood relatives for children. The Medicaid funding is being decreased due to state funding decreasing. A work program for Medicaid is being developed. Child Support new case numbers are going down. The Commissioners need to submit letters of support for an ODOT grant that Council on Aging is applying for, for the county.

The minutes from Thursday, October 9, 2025 were reviewed and approved.

County Prosecutor, Gary Lammers met with Commissioners Wehri, Schlumbohm and Brubaker to discuss Sewer District #1 water well meter next steps for Ryan Ashley & Jason Beckett. Auditor Bob Benroth joined the meeting. Commissioner Schlumbohm mentioned that the Village of Ottawa told us they will not proceed with taking over the districts until all of the residents out there have their meters installed. Out of all of the residents that needed meters, there are only 2 residents left that have not installed them yet. Multiple letters and phone calls have been attempted. Beckett has emailed back one time in response but nothing since the commissioners have responded back to some of his questions. It has been a while and we are to the point of seeing what our next steps are on this. Gary said he suggests that his office will

have to send a final letter to both of the residents with explaining the next step of court intervention with this not being a preference by any means but we cannot keep letting this go. Gary said he asked Cindy the clerk to pull an old resolution probably from early 70s on when the district was formed. Alaina asked Gary if a date can be added to the letter. He said they could do 14 days to contact us or schedule the installation and maybe adding that installation to be done within a month from date of letter. Commissioners also asked Gary to do the certified mailing for this last letter so they know this is important and hopefully get their attention again. Gary will send the letter over for review once he gets it prepared.

Commissioner Schlumbohm left for the day.

Joe Burkhart stopped in to talk with Commissioners Wehri and Brubaker about the camera system. Should it be replaced? We have not had any issues lately where it was needed for documentation. But we do not want to have it down when documentation is needed for an incident or fall. Joe presented a quote for a new camera system. The system is old technology so there is a lag in the footage. A new system would have more days saved also. The quote is for new brains, new memory and converter but no cameras. Eight cameras would need updated within the courthouse. Commissioners Wehri and Brubaker and in agreement to upgrade the camera system. The funding that would have been used for the indigent defenders, since it is now being done regionally, can be put toward security. Joe said he bought two extra key pads for opening the doors at the Annex that can be installed in the Prosecutor's office and Veteran Service office. The cybersecurity program must have a disaster recovery plan, where the servers are backing up information. A test must be done to the recovery plan. The vendor is wanted to be here during the test which must also be after hours, so there would be a cost for that.

Commissioners Wehri and Brubaker left the office to go meet Michael Boaz w/ Board of D/D to participate in the walk through at Brookhill Industries by Miller City.
