Joe Burkhart called in to talk to the Commissioners about his request to run fiber from PCOPS Building to JFS building. The Commissioners asked about the equipment needed. \$17,000

estimate for the conduit, plus the media converters so \$22,000-\$24,000 total for burying conduit. Commissioners asked about security questions from Veteran services, Joe has a request from them but has not talked to them yet.

Mike Lenhart stopped in to talk to Commissioners regarding the ODOT intersection deadline which is Monday October 6. Do they have any input? The SR 613 & 109 intersection will be submitted. SR 65 & 12 intersection in Columbus Grove was also brought up. The engineer will prepare a response for the deadline.

The business agenda was held with Commissioners Wehri, Schlumbohm & Brubaker and Cindy Landwehr, Clerk.

The minutes from Tuesday, September 30, 2025 were reviewed and approved.

Kim Rieman stopped in to talk with Commissioners Wehri, Schlumbohm and Brubaker regarding the tax changes. They also invited Kim to the meeting in Defiance next Friday regarding the proposed property tax changes. The Commissioners are wanting her to prepare something for a public presentation. She will need input from the townships, villages and all other taxing authorities EMS, Board of D/D, ADAMHS Board and Council on Aging. Social media output will also be needed. Kim will also invite the auditor. What kind of timeline are the Commissioners thinking? This could be on the ballot in November of 2026. This will be an educational campaign. If passed in November it will be in effect starting January of 2027. Then health dept funding would come from the townships. The aim is to have the info ready to share Nov 1 through Nov 15. November 6 will be scheduled in the Assembly Room. A representative for the townships, mayors, fire departments will be invited to the initial organizing meeting. Kim will organize the meeting but someone else will have to lead the meeting. Getting all the organizations together and educating people together will help to convey the correct information. The problem will be the Cleveland, Columbus and Cincinnati areas. Kim did ask about the construction requests she made to maintenance, the Commissioners said it would be during the winter.

Leroy Kahle called in to inform the Commissioners it would be 750 ft for the drive way at the Library for their construction drive for Monark, it would be equivalent to about a ½ acre. The drive will put in as soon as the beans are harvested. The drive will then be measured to get a more accurate figure for the farm lease.

Commissioners called Keith Schulte about the driveway through the farm he is renting from the County on Putnam Parkway. The rent adjustment will be figured once the drive is put in. Keith will leave room for the drive and not plant wheat there. Keith is requesting a flag be set for the driveway area.
