Charlie asked about spending money at local businesses within the county versus spending money at the non-local owned businesses, keeping money within the county. Charlie now owns Phillips Oil. The county did get fuel from Phillips in the past. And one winter there were some issues with a handful of trucks and the fuel from Phillips. The county garage now gets Brooky's fuel which has sold and their fuel comes from National Oil out

of Indiana. Phillips sells Marathon fuel which is local. Mr. Scheckelhoff would like to see the county purchasing local rather than sending the county money to another state. The county should be supporting local businesses and keeping local money local. Brooky's also got the contract for fuel for the O-G school buses. Charlie is asking the Commissioners to recommend to the Engineer to purchase fuel from a local vendor rather than a now non-local vendor and consider purchasing county fuel from Phillips Oil. Phillips Oil has four full time employees and a fill station on Road 7 in Leipsic. They pride themselves on quality products and local service. Charlie shared his contact information. The Commissioners will talk to Mike Lenhart the Engineer about trying fuel from Phillips Oil.

The business agenda was held with Commissioners Schlumbohm, Wehri, and Brubaker, and Cindy Landwehr, Clerk.

Commissioners Wehri, Schlumbohm and Brubaker left to go to the EMA Office of Public Safety to meet with EMA Brian Hilvers & Ruth Gerding to discuss the opioid grant.

Putnam County's OSU Jason Hedrick & Beth Scheckelhoff met with Commissioners Wehri, Schlumbohm and Brubaker to discuss the Putnam/OSU budget. Jason and Beth gave a program review for OSU Extension and some highlights. A grant for some barn improvements was awarded for about \$14,000. 4-H participation has held steady within the county. They also have the master gardener program. They do get many questions from the public regarding bug and weed identification, they provide the pesticide training and maintain the SHARP site. Putnam is outpacing other counties recovering from the COVID restrictions. The OSU extension budget was reviewed. Jason explained the office staffing and portions covered by OSU. SNAP-Ed position is federally funded through job & Family services but is an OSU employee. As of 11/30/2025 the SNAP-Ed program will no longer exist. Lisa Hoffman is eligible to retire at the end of her program. Putnam has easy access to specialists who will provide services for the county. Local funding must come in first then the state and federal dollar s come in. The budget request was reviewed. Personnel is the largest expense, the office expenses are kept at a minimum and reduced if possible. They do get funds from the Putnam County 4-H Council and the Fair Board to help supplement the budget. \$205,500 is the ask for 2026. Jason's role as area leader may be changing and the OSU backfill amount may be changed. Jason would be back in the office and the part time summer help would not be needed. The rent cost is an Inkind contribution from the county per ORC. The trend is a 2-4% increase based on salaries. Are there any other grants that are being sought for the fairgrounds, not at this time. Ag Credit is also a big supporter of the fair. The proposed property tax changes were discussed and it was suggested to stay aware of the situation. The county will have to focus on public safety since those services are essential and the mandated services.
