Nate's truck is eleven years old and Tim would like to look as getting a new one. The fairgrounds pickup is also in need of being replaced, Nate's truck could be traded to the fairgrounds. Commissioners Wehri and Brubaker told Tim to get prices on new trucks. Tim also asked about him and his guys going to CCAO winter conference for the maintenance session. Brad told Tim that the assembly for the fuel intake on the truck needs a bolt in it. Recycling needs to put new tires on the skid loader. The trees are down and gone at EMS house. There is a tree at Brookhill that was taken done and the tree needs to be hauled away. Tim can take care of it. Tim asked how many contractors showed up for the pre-bid walk through. There were a few contractors.

Patrick McCauley with Office of Treasurer of State Robert Sprague met with Commissioners Wehri and Brubaker to discuss office updates. Mr. McCauley listed the Treasurer's office programs:

- Star Ohio-investment program, (which Putnam County does use)
- Ohio Homebuyer Plus Program-allows individuals to save for a home at a higher interest rate, \$1.5 billion in deposits currently,
- Ag Link-agri-business gets special rate for operating loans, aided the poultry farms during bird flu epidemic,
- Buckeye Business Advantage-small business 150 employees or less, 51% of business in Ohio, reduced rate good for two years for operations.
- O-Map-Ohio Market access program, bonds for financing.
- Stable Accounts-allow individuals with disability to save money and does not affect their federal benefits. This money can be used for living expenses, to purchase a home, car or medical expenses. Anything to improve their quality of life. If able to work additional money is available. The state will pay the account fees with Vestwell. Stable accounts are no longer subject to public info requests. Medicaid cannot come back on these accounts, it can be willed to an heir. The age is being raised to 46 which will allow more people to be qualified. Auto deduction is provided to contribute to Stable accounts.
