He introduced their new hire, Ryan Schroeder, who joined the meeting. Curt said he wanted to meet with the commissioners to get up to speed with this project. ODNR may have funds to do things out at the landfill. Bowser Morner was the one that responded back to the US EPA and the permit mod is on hold until those items were addressed and the US EPA is ok with the solutions. Alaina said the permit mod that was done with Jeff Giesige and Commissioner Wehri, that is on hold, was submitted before the US EPA inspection and work they want done so the medication to the permit may need re-done. Curt said we may want to have a sit down with everyone involved to see if Bowser Morner will need to do a different permit mod and where everyone is in the process and exactly what projects were going to be done like closing off the big pond. Commissioners agreed we could get a meeting set up again. Curt wants to avoid a two-stage ditch and wants to open the current ditch up to the ponds. He is hoping the water from heavy rain would then

just go out over the wetlands. He said that any dirt from opening the ditch could go on the banks to help with making the mowing easier and they could clear up the paths and slopes around the ponds. Curt is going to have a meeting with ODNR just to see what his options are. Commissioner Schlumbohm said we can see about setting up a zoom in the next week or two, sometime after Thanksgiving. Maybe we will have a response back from the US EPA in the meantime.
