The Pledge of Allegiance was recited by Commissioners Wehri, Schlumbohm and Brubaker, Sheriff Siefker Officer Mark Brecht and Kelly Iliff.

Sheriff Siefker, Mark Brecht, and Kelly Iliff met with Commissioners Wehri Schlumbohm and Brubaker to discuss the purchasing of new sheriff vehicles. Officers Brecht and Iliff are newly promoted. The department is looking to purchase a Chevy Tahoe with drone package. This

would include a big screen tv with the drone all inside the vehicle so the drone footage can be viewed on site. There have been an increase of calls needing the drone for search and rescue. Officer Brecht's sons are licensed drone operators for the county along with Brandon Barlage. There are increased options for licensing for a drone also. A quote for the Tahoe with the drone package was presented. The TV would have to be added. The Sheriffs office would like to purchase two Ford Explorers along with the Tahoe with the drone packed for the 2026 year. \$200,000 has been budgeted for sheriff vehicles for 2026. The Tahoe would not be a road patrol vehicle so it would not have high miles. The TV can be purchased separately to save money. The drone package in the Tahoe would have storage compartments for the drone. It would have the electrical equipment also needed for the drone. The Commissioners asked about a need for another drone. Yes, another drone would be needed as well. Adding a new drone with the vehicle could be purchased as well. The Commissioners asked for the Sheriff's vehicle list to see what is in inventory. The cars with newer equipment will be on the road and the ones with older equipment will be rotated out. There is a forfeiture vehicle that is used also and there were many vehicles purchased with covid funds. Five-year plans were request by the Commissioners on the HVAC on the jail and other controls in the jail and infrastructure items so we can be proactive rather than reactional on replacing and upgrading. The same way with the vehicles a plan for replacements based on wear and tear on the cars. Other equipment has been upgraded like the plates and vest for the SRT team.

The business agenda was held with Commissioners Wehri, Schlumbohm and Brubaker and Cindy Landwehr, Clerk.

The minutes from Thursday November 20, 2025 were reviewed and approved.

Commissioners Wehri, Schlumbohm and Brubaker and Tim Schnipke met with Cheyanne Eagleson for a job interview for the custodial position.

Tim Schnipke presented a quote for a new maintenance truck. A Ford F350 is cheaper than a Chevy truck the same size. This would be to replace Nate's truck. The plow on the diesel truck would go on Nate's truck. This is just a proposal.

Ottawa Township Trustees Don Croy, Steve & Jim Leopold & the future trustee, Jeff Heringhaus met with Commissioners Wehri, Schlumbohm and Brubaker to discuss Sewer District #1. Don Croy said he is getting lots of messages from Kyle Stechschulte from the Village on getting the agreement done. Don said we need to let the residents know about this. He wants the residents to know about this before they go forward with the agreement. Don wants to know if the residents could be informed and wants to know whose responsibility it should be to inform them. Don said he feels that the public should meet with all three entities to be represented and he put a letter together. Jim asked if everything is ready to be turned over. Jeff asked about possibly doing it by phases with the voting so vote will count more. Commissioner Schlumbohm said maybe we can look at down the road billing by usage by the meters we had them put in. He mentioned that maybe Ottawa would work with us by reading the meters and get us the info for the billing. Don will get a copy of the letter to us to review and we will print off labels for them.
